RESOLUTION NO. 82-2013

A RESOLUTION OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT AUTHORIZING THE ADVERTISEMENT FOR BIDS AND THE DISTRIBUTION OF A PRELIMINARY OFFICIAL STATEMENT FOR THE PURCHASE OF THE PRINCIPAL AMOUNT OF ITS (I) VARIOUS PURPOSE GENERAL OBLIGATION BONDS, SERIES 2013A IN AN AMOUNT NOT TO EXCEED \$14,000,000; AND (II) VARIOUS PURPOSE GENERAL OBLIGATION REFUNDING BONDS, SERIES 2013B IN A PRINCIPAL AMOUNT NOT TO EXCEED \$10,000,000.

WHEREAS, the Lexington-Fayette Urban County Government has previously determined the necessity of financing various street and highway improvements including the rehabilitation and paving of existing roads and streets throughout Lexington, Fayette County, Kentucky (collectively, the "Project"); and

WHEREAS, the Lexington-Fayette Urban County Government has determined to proceed with the advertisement of bids for the purchase of its Various Purpose General Obligation Bonds, Series 2013A (the "Series 2013A Bonds") in the principal amount not to exceed \$14,000,000, in order to provide funds to (i) improve various streets and highways including the rehabilitation and paving of existing roads and streets throughout Lexington, Fayette County, Kentucky, and (ii) pay the costs of issuing the Series 2013A Bonds.

WHEREAS, the Lexington-Fayette Urban County Government, heretofore issued its \$9,640,000 Lexington-Fayette Urban County Government General Obligation Bonds (Day Treatment Center, Multi-Use Facility and Expansion Area Boulevard Projects), Series 2004C (the "Series 2004C Prior Bonds,"), the proceeds of which were used to finance the (i) acquisition, construction and equipping of a day treatment facility, (ii) acquisition, renovation and equipping of a multi-use facility and (iii) acquisition of rights of way and construction of road improvements (the "Series 2004C Project"); and

WHEREAS, the Lexington-Fayette Urban County Government, heretofore issued its \$4,490,000 Lexington-Fayette Urban County Government General Obligation Bonds, Series 2005C (the "Series 2005C Prior Bonds"), the proceeds of which were used to finance (i) the purchase of a development rights program or a program to purchase conservation easements, and (b) the renovation and upgrade of space in government office buildings and repairs to parking garages; (the "Series 2005C Project"); and

WHEREAS, the Lexington-Fayette Urban County Government, heretofore issued its \$10,310,000 Lexington-Fayette Urban County Government General Obligation Bonds (Stormwater Improvements, Neighborhood Redeployment, Bluegrass Aspendale Parkway, Veterans Park Fire Station and Police Car Projects), Series 2006B (the "Series 2006B Prior Bonds,"), the proceeds of which were used to finance the (i) the acquisition and construction of stormwater improvements, (ii) neighborhood redevelopment projects, and (iii) purchasing police cars (the "Series 2006B Project");

WHEREAS, the Lexington-Fayette Urban County Government, heretofore issued its \$2,055,000 Lexington-Fayette Urban County Government General Obligation Bonds, Series 2006C (Development Rights Project), (the "Series 200CB Prior Bonds," and together with the Series 2004C Prior Bonds, the Series 2005C Prior Bonds and the Series 2006B Prior Bonds, the "Prior Bonds"), the proceeds of which were used to finance the purchase of a development rights program or a program to purchase conservation easements (the "Series 2006C Project," and together with the Series 2004C Project, the Series 2005C Project and the Series 2006B Project, the "Prior Project").

WHEREAS, the Lexington-Fayette Urban County Government has determined that due to the present conditions of the municipal market it is advantageous and in the best interests of

the Lexington-Fayette Urban County Government for the purpose of realizing interest cost savings (as determined by the Director of Finance) to proceed with the advertisement of bids for the purchase of its Various Purpose General Obligation Refunding Bonds, Series 2013B (the "Series 2013B Refunding Bonds" and together with the Series 2013A Bonds, the "Series 2013 Bonds") in one or more subseries, in a principal amount not to exceed \$10,000,000, in order to provide funds to (i) refund all or a portion of the Prior Bonds and (ii) pay the costs of issuing the Series 2013B Refunding Bonds; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT (THE "URBAN COUNTY COUNCIL"):

SECTION 1. The Lexington-Fayette Urban County Government, an urban county government and political subdivision of the Commonwealth of Kentucky, shall issue its Series 2013A Bonds in one or more subseries in the principal amount not to exceed \$14,000,000, in order to provide funds to (i) improve various streets and highways including the rehabilitation and paving of existing roads and streets throughout Lexington, Fayette County, Kentucky, and (ii) pay the costs of issuing the Series 2013A Bonds. The Lexington-Fayette Urban County Government shall also issue its Series 2013B Refunding Bonds in a principal amount not to exceed \$10,000,000 (provided that the refunding of the Series 2004C Prior Bonds, Series 2005C Prior Bonds, the Series 2006B Prior Bonds and/or the Series 2006C Prior Bonds shall result in debt service savings for the Lexington-Fayette Urban County Government as determined by the Commissioner of Finance and the financial advisors to the Lexington-Fayette Urban County Government) in order to provide funds to (i) refund all or a portion of the Prior Bonds and (ii) pay the costs of issuing the Series 2013B Refunding Bonds.

SECTION 2. The Lexington-Fayette Urban County Government shall comply with the requirements of KRS Chapter 66 by advertising for bids for the purchase of the Series 2013 Bonds. The Mayor, the Clerk of the Urban County Council and the Commissioner of Finance are hereby authorized to prepare such instruments and to distribute such information as shall be necessary to accomplish the foregoing, including preparation of a Preliminary Official Statement (the "Preliminary Official Statement") which Preliminary Official Statement is to be deemed final in accordance with Rule 15c2-12 of the Securities and Exchange Commission (the "Rule"). In order to enable prospective purchasers to submit bids for the purchase of the Series 2013 Bonds, the Lexington-Fayette Urban County Government hereby covenants and agrees that it will execute, comply with and carry out all of the provisions of a continuing disclosure certificate (the "Continuing Disclosure Certificate") in connection with the issuance of the Series 2013 Bonds. Failure to comply with any such provisions of the Continuing Disclosure Certificate shall not constitute a default on the Series 2013 Bonds; however, any holder of the Series 2013 Bonds, including the beneficial owners of the Series 2013 Bonds, may take such action as may be necessary and appropriate, including seeking specific performance, to cause the Lexington-Fayette Urban County Government to comply with its obligations under the Continuing Disclosure Certificate. Further the Mayor is hereby authorized and directed on behalf of the Lexington-Fayette Urban County Government to execute all such instruments as shall be necessary to accomplish all of the foregoing.

SECTION 3. Such proposals shall be opened and reviewed by the Commissioner of Finance, and shall be acted upon by the Mayor on that same day in accordance with the terms of the bond ordinance with respect to the Series 2013A Bonds and the bond ordinance with respect to the Series 2013B Refunding Bonds. The Lexington-Fayette Urban County Government

hereby approves the "Notice of Bond Sale," substantially in the form attached hereto to be published as required by law.

SECTION 4. The Mayor shall, in a certificate of award accepting the successful bid for the Series 2013 Bonds (the "Certificate of Award"), determine the exact principal amount of Series 2013 Bonds to be issued, the subseries designations of the Series 2013 Bonds, the rate or rates of interest which said Series 2013 Bonds shall bear, redemption provisions and the interest rate or rates on said Series 2013 Bonds shall be automatically fixed at the rate or rates set out in the successful bid accepted by said Certificate of Award. The proceeds of the sale of the Series 2013A Bonds shall be applied to the costs of the Project and paying the costs of issuance of the Series 2013A Bonds, and shall be expended as provided in the bond ordinance authorizing the Series 2013A Bonds. The proceeds of the sale of the Series 2013B Refunding Bonds shall be applied to the costs of the refunding of all or a portion of the Prior Bonds and paying the costs of issuance of the Series 2013B Refunding Bonds, and shall be expended as provided in the bond ordinance authorizing the Series 2013B Refunding Bonds.

SECTION 5. In the event that no bid shall be accepted for the purchase of the Series 2013 Bonds, bids may again be solicited for the purchase of the Series 2013 Bonds at a future date and hour at the discretion of the Mayor and the Commissioner of Finance, without the necessity of further authorization by the Urban County Council of the Lexington-Fayette Urban County Government.

SECTION 6. All resolutions or orders or parts thereof, if any, in conflict with the provisions of this Resolution, are to the extent of such conflict, hereby repealed.

SECTION 7. This Resolution shall become effective upon the date of its passage.
