

**AGREEMENT BETWEEN
WINSTREAM COMMUNICATIONS INC., AND
THE LEXINGTON FAYETTE URBAN COUNTY GOVERNMENT,
LEXINGTON-FAYETTE COUNTY, KENTUCKY**

THIS AGREEMENT is made and entered into as of this 1st day of September, 2023, by and between the LEXINGTON FAYETTE URBAN COUNTY GOVERNMENT, KENTUCKY, an urban county government pursuant to KRS Chapter 67A (hereinafter referred to as “LFUCG”) and the WINDSTREAM COMMUNICATIONS, INC., (hereinafter referred to as “WINDSTREAM”), collectively referred to as the “PARTIES.”

RECITALS:

WHEREAS, WINDSTREAM may construct, replace and maintain facilities within the LFUCG right-of-way in accordance with the LFUCG Code of Ordinances, Section 17C; and

WHEREAS, LFUCG owns and maintains that portion of the right-of-way identified as Manchester Street, between W. High Street and Oliver Lewis Way, located in Lexington, Kentucky; and

WHEREAS, WINDSTREAM has constructed, replaced and maintained their infrastructure in various locations along Manchester Street within the LFUCG right-of-way, in Lexington, Kentucky; and

WHEREAS, LFUCG has a construction project named "Town Branch Park Public Access Improvements" with construction plans by the same title, hereinafter referred to as "Park Access Project" that requires relocation of a portion of the WINDSTREAM’S infrastructure on Manchester Street: specifically cables suspended on utility poles; and

WHEREAS, the cost to relocate infrastructure within the right-of-way is borne by WINDSTREAM, if such infrastructure is relocated in kind; and

WHEREAS, LFUCG desires the relocated cables to be buried underground in lieu of suspending cables from utility poles; and

WHEREAS, the cost to bury cables is greater than the cost to suspend cables from utility poles;

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, the PARTIES hereby agree as follows:

(1) **INCORPORATION OF RECITALS.** The above recitals are incorporated herein as if fully set forth.

(2) **EXECUTION OF UTILITY RELOCATION.** WINDSTREAM agrees, upon receipt of a Notice to Proceed issued by LFUCG, to relocate and underground their facilities in accordance with the plans titled “Town Branch Park Public Access Improvements”, with color-coded and keyed notations by WINDSTREAM, attached hereto and incorporated herein as **Exhibit A**, by October 31, 2023.

(3) **REIMBURSEMENT OF ADDITIONAL COST BY LFUCG.** Within thirty days after successful completion of relocation and undergrounding of facilities by WINDSTREAM, LFUCG shall reimburse WINDSTREAM the total of **TWENTY THOUSAND NINE HUNDRED NINETY DOLLARS AND EIGHTY-FIVE CENTS (\$20,990.85)**, as shown by the proposal prepared by WINDSTREAM, dated July 5, 2023, and attached hereto and incorporated herein as **Exhibit B**. LFUCG shall not be responsible for any additional cost borne by WINDSTREAM in the relocation or undergrounding of its facilities required herein.

(4) **NOTICE.** Any notice or consent authorized or required by this Agreement shall be in writing and either delivered personally or sent postage prepaid by certified mail or registered

mail, return receipt requested, directed to the other party at the address set forth in this Section 4 or such other parties or addressees as may be designated by either WINDSTREAM or LFUCG by notice given from time to time in accordance with this section:

Any notice or consent given in accordance with this Section 4 shall be deemed received upon delivery in person or three days after depositing it in an office of the United States Postal Service or any successor governmental agency.

(5) **ASSIGNMENT.** The PARTIES shall not transfer or assign all or any part of their rights or obligations hereunder without the express written consent of the other party. No assignment shall relieve, release or discharge the assigning party of its obligations, except as provided therein.

(6) **NO LEGAL ENTITY CREATED.** The PARTIES acknowledge that this Agreement does not create a legal entity, partnership, joint venture or any association taxable as a corporation.

(7) **COMPLIANCE WITH LAWS.** The PARTIES shall comply with all applicable laws in the performance of their activities under this Agreement. In addition, all rights and obligations of the PARTIES under this Agreement shall be subject to all applicable laws, rules,

regulations, applicable orders and decrees of any court having jurisdiction over the party in question, and nothing in this Agreement shall be construed to require either party to take any action which would cause such party to violate such laws, rules, regulations, applicable orders or decrees or to violate any contract or agreement to which such party is party.

(8) **INDEMNIFICATION.**

- a. At all times relevant to the performance of this Agreement, WINDSTREAM shall maintain insurance coverages in at least the following amounts, which shall be properly filed and approved by the Kentucky Department of Insurance. Evidence of such coverage shall be made available to LFUCG upon request. General Liability (\$1 million per occurrence, \$2 million aggregate or \$2 million combined single limit); Commercial Automobile Liability (combined single, \$1 million per occurrence); (if applicable); Professional Liability (\$1 million per occurrence, \$2 million aggregate); Worker's Compensation (Statutory); and Employer's Liability (\$1 million).
- b. WINDSTREAM shall indemnify, defend and hold harmless LFUCG and its elected and appointed officials, employees, agents, volunteers, and successors in interest, from and against any and all liability, damages, and losses, including but not limited to: demands, claims, liens, suits, notices of violation from governmental agencies, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by WINDSTREAM's performance of, or breach of this Agreement and/or the provision of goods or services, provided that (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of

WINDSTREAM or its officials, employees, or agents; and (b) not caused solely by willful misconduct of LFUCG.

c. WINDSTREAM understands and agrees that its obligation to defend LFUCG includes the obligation to investigate, handle, respond to, resist, provide a defense for, and defend claims, at WINDSTREAM's expense, using attorneys approved in writing by the LFUCG, which approval shall not be unreasonably withheld.

d. WINDSTREAM further understands and agrees that its obligation to indemnify includes, but is not limited to: attorney fees and expenses, costs of litigation, court and administrative costs, expert witness fees and expenses, judgments, fines, penalties, interest, all environmental cleanups and remediation costs of whatever kind, and any liability arising from death, injury, or damage of any kind, to any person, including employees and agents of WINDSTREAM and LFUCG, and damage to, or destruction of, any property, including the property of LFUCG.

e. This provision shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this Agreement.

f. WINDSTREAM understands that LFUCG is a political subdivision of the Commonwealth of Kentucky and acknowledges and agrees that LFUCG is unable to provide indemnity or otherwise save, hold harmless, or defend the WINDSTREAM in any manner.

(9) **REGISTRATION; COMPLIANCE; AUTHORITY TO SIGN.**

WINDSTREAM shall be lawfully registered or authorized to do business in the Commonwealth of Kentucky and Lexington-Fayette County and shall at all times comply with any and all applicable federal, state, and local laws, ordinances, and regulations. LFUCG may request proof that WINDSTREAM has timely filed federal, state, or local tax forms which shall be provided by

WINDSTREAM on a timely basis. The person signing this Agreement on behalf of WINDSTREAM is fully authorized to do so. Neither the execution of this Agreement, nor the consummation of any transaction contemplated herein, violates any laws, rules, regulations or ordinances.

(10) **EQUAL OPPORTUNITY; FAIRNESS ORDINANCE.** WINDSTREAM shall provide equal opportunity in employment for all qualified persons, and shall (a) prohibit discrimination in employment because of race, color, creed, national origin, sex, age, sexual orientation, gender identity, or handicap, (b) promote equal employment through a positive, continuing program of equal employment, and (c) cause any subcontractor or agency receiving funds provided pursuant to this Agreement to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices. WINDSTREAM agrees to comply with LFUCG's Fairness Ordinance (Ordinance No. 201-99) and all sources of applicable law, including those specified in any Exhibit attached to this Agreement and incorporated herein by reference.

(11) **BENEFIT.** This Agreement shall inure to the benefit of the PARTIES hereto, their respective legal representatives, successors and assigns. This Agreement does not create a contractual relationship with or right of action in favor of a third party against either WINDSTREAM or LFUCG.

(12) **GOVERNING LAW.** This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky.

(13) **AMENDMENT.** This Agreement may be amended only by written agreement signed by both LFUCG and WINDSTREAM.

(14) **HEADINGS.** The section headings used herein are for convenience purposes only and do not constitute matters to be construed in interpreting this Agreement.

(15) **VENUE/JURISDICTION.** The PARTIES agree that any suit, action or proceeding with respect to this Agreement may only be brought in or entered by, as the case may be, the courts of the Commonwealth of Kentucky situated in Lexington, Fayette County, Kentucky, or the United States District Court for the Eastern District of Kentucky, Lexington Division.

(16) **WAIVER.** The waiver by either PARTY of any breach of any provision of this Agreement shall not constitute a continuing waiver or waiver of any subsequent breach by either party of either the same or another provision.

(17) **NO PRESUMPTION.** WINDSTREAM and LFUCG are each represented by counsel and have participated jointly in the negotiation and drafting of this Agreement. In the event that any ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by WINDSTREAM and LFUCG, and no presumption or burden of proof shall arise favoring or disfavoring any party by virtue of the authorship of any of the provisions of this Agreement.

(18) **DUPLICATES.** This Agreement may be executed in duplicate counterparts, each of which shall be deemed an original. In the event that any signature is delivered by facsimile or by email of a “.pdf” format data file, such signature shall create a valid and binding obligation of such Party with the same force and effect as if such facsimile or “.pdf” signature page were an original thereof.

(19) **TERM AND TERMINATION.** Except for the requirements in Section 8, Agreement shall expire upon the date upon which LFUCG has reimbursed WINDSTREAM as provided in Section 3.

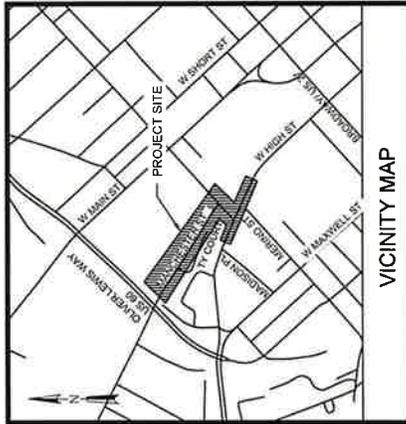
