

GRANT OF EASEMENT

This **EASEMENT** is made and entered into this 8 day of 11, 2013, by and between **KURT McDONALD and MELISSA McDONALD**, husband and wife, 600 Winter Park Court, Lexington, Kentucky 40517 ("Grantor"), which is also the in-care of tax mailing address for the current tax year, and the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507 ("Grantee");

WITNESSETH:

That for and in consideration of the sum of **Six Thousand Two Hundred Twenty Dollars and 80/100 Cents (\$6,220.80)**, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and does hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, the permanent right to lay, construct, operate, repair, reconstruct and remove sanitary sewer improvements and appurtenances thereto, which sanitary sewer improvements and appurtenances shall be of such dimension, character, construction and use determined by Grantee, along, through, under and across the following tract of land located in the confines of Lexington-Fayette County, Kentucky, and more particularly described as follows:

Permanent Sanitary Sewer Easement
3368 Valhalla Drive
Century Hills Sanitary Sewer Improvement Project

Described on Exhibit A attached hereto and incorporated herein by reference.

FURTHER, for and in consideration of the foregoing sum, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and does hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, the temporary right to excavate, grade, construct, alter, regrade and perform related work

for the purpose of sanitary sewer construction, repair, installation and relocation through and across the following tract of land located within the confines of Lexington-Fayette County, Kentucky, to-wit:

All temporary construction easements, if any, are described on Exhibit B attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD the above-described easement together with all rights, privileges, appurtenances and improvements thereunto belonging unto Grantee, its successors and assigns forever, for the purposes and uses herein designated.

The above-described temporary construction easement will expire upon completion of the construction of the improvement project on the land adjacent to this easement, runs with the land for the duration of the improvement project on the adjacent land, and is binding upon the heirs and assigns of the Grantors.

Grantors do hereby covenant to and with said Grantee, its successors and assigns forever, that he are lawfully seized in fee simple of said property and has good right to sell and convey the easements conveyed herein, and that he will **WARRANT GENERALLY** said title.

Grantors shall have the full right to use the surface of the land lying over said permanent easement for any purpose desired, provided such use will not interfere with the Grantee's free use of the easement herein granted and provided further that no building or structure shall be erected upon, across, over or through said permanent easement without the prior written consent of the Grantee.

The obtaining of this easement was authorized by Resolution No. 389-2013 passed by the Lexington-Fayette Urban County Council on July 9, 2013. Pursuant to

KRS 382.135(2)(a), this public utility easement is exempt from the requirements related to certificate of consideration. This conveyance is exempt from real estate transfer tax pursuant to KRS 142.050.





All those tracts or parcels of land situated on the southerly side of Valhalla Drive at its terminus, in Lexington, Fayette County, Kentucky, and more fully described and bounded as follows, to-wit:

Permanent Sanitary Sewer Easement:

Beginning at a point in the common line of Lot 33 and Lot 34, Block H, Unit 4-A, Section 2 of Century Hills Subdivision (Plat Cabinet C, Slide 17), said point being approximately 33.5 feet northeasterly from the rear common corner of said lots as measured along the common line; thence along the common line of Lots 33 and 34, N 01° 19' 47" E 22.46 feet; thence through Lot 33 for two calls, S 61° 37' 10" E 52.15 feet and S 69° 20' 31" E 17.60 feet to a point in the common line of Lot 33 aforesaid and Lot 9, Block I, Unit 4-B of Century Hills Subdivision (Plat Cabinet D, Slide 151); thence along said common line, S 27° 38' 16" W 20.15 feet; thence again through Lot 33, parallel with and twenty feet southwesterly from the second and third calls cited above, in reverse order, N 69° 20' 31" W 16.51 feet and N 61° 37' 10" W 43.29 feet to the beginning and containing 1296 square feet.

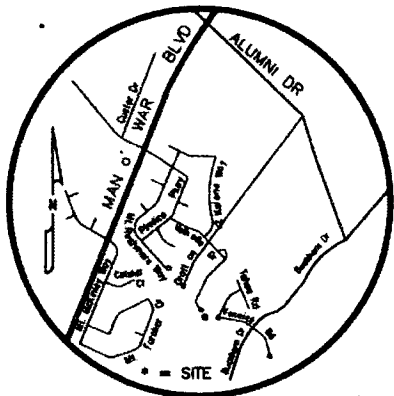
Temporary Construction Easement - Tract 1:

Beginning at the northwesterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 33 and Lot 34, Block H, Unit 4-A, Section 2 of Century Hills Subdivision (Plat Cabinet C, Slide 17); thence along said common line, N 01° 19' 47" E 11.23 feet; thence through Lot 33, parallel with and ten feet northeasterly from the northeasterly line of the above described permanent sanitary sewer easement, for two calls, S 61° 37' 10" E 56.59 feet and S 69° 20' 31" E 18.15 feet to a point in the common line of Lot 33 aforesaid and Lot 9, Block I, Unit 4-B of Century Hills Subdivision (Plat Cabinet D, Slide 151); thence along said common line, S 27° 38' 16" W 10.07 feet; thence again through Lot 33, along the northeasterly line of the above described permanent sanitary sewer easement, N 69° 20' 31" W 17.60 feet and N 61° 37' 10" W 52.15 feet to the beginning and containing 723 square feet.

Temporary Construction Easement - Tract 2:

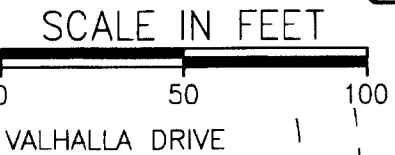
Beginning at the southwesterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 33 and Lot 34, Block H, Unit 4-A, Section 2 of Century Hills Subdivision (Plat Cabinet C, Slide 17); thence through Lot 33, along the southwesterly line of the above described permanent sanitary sewer easement, for two calls, S 61° 37' 10" E 43.29 feet and S 69° 20' 31" E 16.51 feet to a point in the common line of Lot 33 aforesaid and Lot 9, Block I, Unit 4-B of Century Hills Subdivision (Plat Cabinet D, Slide 151); thence along said common line, S 27° 38' 16" W 10.07 feet; thence again through Lot 33, parallel with and ten feet southwesterly from the southwesterly line of the above described permanent sanitary sewer easement, for two calls, N 69° 20' 31" W 15.96 feet and N 61° 37' 10" W 38.86 feet to a point in the common line of Lots 33 and 34 aforesaid; thence with said common line, N 01° 19' 47" E 11.23 feet to the beginning and containing 573 square feet.

Being a twenty-foot wide permanent sanitary sewer easement and ten-foot wide temporary construction easements on a portion of the same property conveyed to Kurt McDonald and Robert Gant and Donna Gant, his wife, by deed dated December 14, 1990, and recorded in Deed Book 1572, Page 245. By deed dated November 14, 2002, and of record in Deed Book 2323, Page 442, Robert Gant and Donna Gant, husband and wife, conveyed their interest in subject property to Kurt McDonald, a single person. Kurt McDonald is now married to Melissa McDonald. Subject property being designated as Lot 33, Block H, Unit 4-A, Section 2 of Century Hills Subdivision as per the Final Record Plan recorded in Plat Cabinet C, Slide 17. All of the above referenced instruments are of record in the Fayette County Clerk's office.

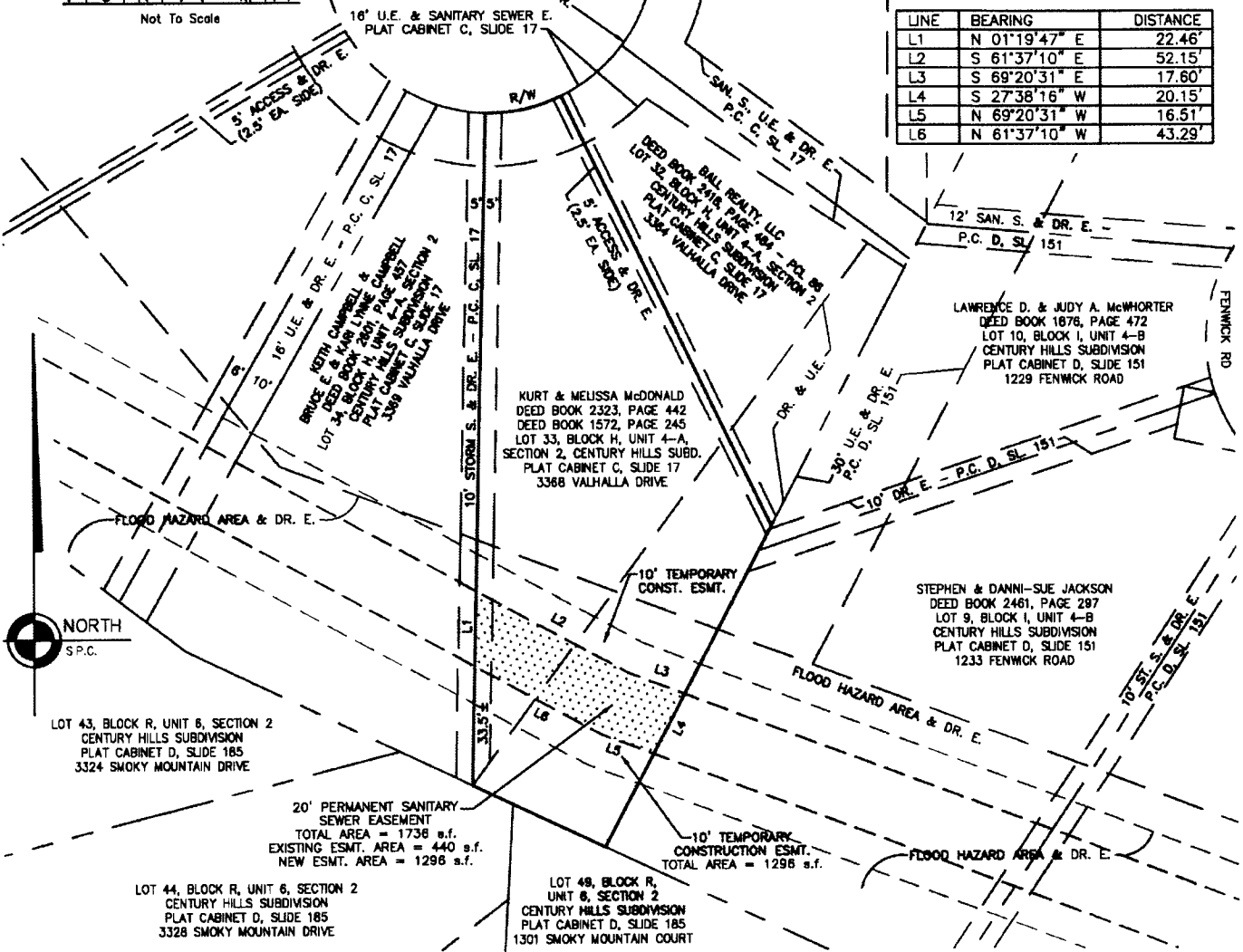
