Project Safe Neighborhoods Project –Lexington Police will be part of the Project Safe Neighborhoods Task Force which includes US Attorney’s Office, ATF, DEA, FBI, ICE, Marshal’s Service, Federal Probation & Parole, the KY State Police, State Probation and Parole, the Commonwealth’s Attorney, County Attorney, Fayette County Sheriff’s Office and Fayette County School Police. The PSN Task Force will increase information sharing and collaboration to identify the violent offenders most likely to continue to engage in violent crime, and then develop proactive investigations and post-arrest coordination to prevent further acts of violence and maximize investigative outcomes. Violent crime data and intelligence information pertaining to the groups and individuals involved in violent crime.

Lexington Police will receive the below funds for equipment and overtime for targeted enforcement and surveillance on gun, drug, gangs and assaultive related crime in prioritized areas.
