AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) VACANT CLASSIFIED POSITION OF ADMINISTRATIVE OFFICER SR., GRADE 526E, AND CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF ADMINISTRATIVE OFFICER, GRADE 523E IN THE DEPARTMENT OF INFORMATION TECHNOLOGY; ABOLISHING ONE (1) VACANT CLASSIFIED POSITION OF TECHNICAL SPECIALIST, GRADE 515N, IN THE DIVISION OF COMPUTER SERVICES; ABOLISHING ONE (1) VACANT CLASSIFIED POSITION OF STAFF ASSISTANT SR., GRADE 510N, IN THE DIVISION OF PURCHASING; CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF HUMAN RESOURCES ANALYST, GRADE 520E, IN THE DIVISION OF HUMAN RESOURCES; CREATING THREE (3) CLASSIFIED CIVIL SERVICE POSITIONS OF TELECOMMUNICATOR, GRADE 514N AND CREATING ONE (1) CLASSIFIED POSITION OF RADIO/ELECTRONICS SPECIALIST, GRADE 515N, IN THE DIVISION OF ENHANCED 911, CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF FLEET OPERATIONS MANAGER, GRADE 521E, IN THE DIVISION OF FIRE AND EMERGENCY SERVICES, CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF GRANTS MANAGER SR., GRADE 526E, AND ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF AFFORDABLE HOUSING SPECIALIST, GRADE 518N, IN THE DIVISION OF GRANTS AND SPECIAL PROGRAMS, CREATING ONE (1) UNCLASSIFIED CIVIL SERVICE POSITION OF ADMINISTRATIVE AIDE TO THE MAYOR SR., GRADE 524, IN THE OFFICE OF THE MAYOR, AND ABOLISHING ONE (1) VACANT UNCLASSIFIED CIVIL SERVICE POSITION OF STAFF ASSISTANT SR., GRADE 510N, IN THE BOARD OF ELECTIONS, CREATING ONE (1) UNCLASSIFIED CIVIL SERVICE POSITION OF PUBLIC WORKS APPRENTICE, GRADE 504N, IN THE DIVISION OF STREETS AND ROADS, AND AMENDING THE SWORN AUTHORIZED STRENGTH BY CREATING ONE (1) POSITION OF POLICE SERGEANT, GRADE 315N, AND CREATING FIVE (5) POSITIONS OF POLICE OFFICER, GRADE 311N, IN THE DIVISION OF POLICE, EFFECTIVE UPON PASSAGE OF COUNCIL.
