Dear Mr. Wente:

The purpose of this letter is to provide assurances from the two property owners at 321 and 317 Henry and 610, 611, 613 3rd St, Lexington, KY to LFUCG. The below signatories are the record owners of these properties. We have requested that a dumpster pad be located at the end of what was known as "King St", but that has now or will shortly be closed by the LFUCG council, and thus revert back to us. Please see attached exhibit showing the area of the dumpster pad. This dumpster pad will serve both owners.

Division of Waste Management has requested this letter because it has determined that the dumpster pad, as shown on the attached plan, sits above a sanitary sewer easement.

The below owners agree that in the event that LFUCG needs to dig-up, replace, access, re-locate, or reconfigure its sanitary sewer line, that they will be solely responsible for the repair to their dumpster pad.

The below entities agree that they will hold harmless LFUCG from any claims that LFUCG must repair or replace the dumpster pad in such event.

Once King Street is procedurally closed by LFUCG, the undersigned will execute and record easements to cover access, ingress, egress, the dumpster pad, the dumpster turnaround, and utilities in the shared drive.

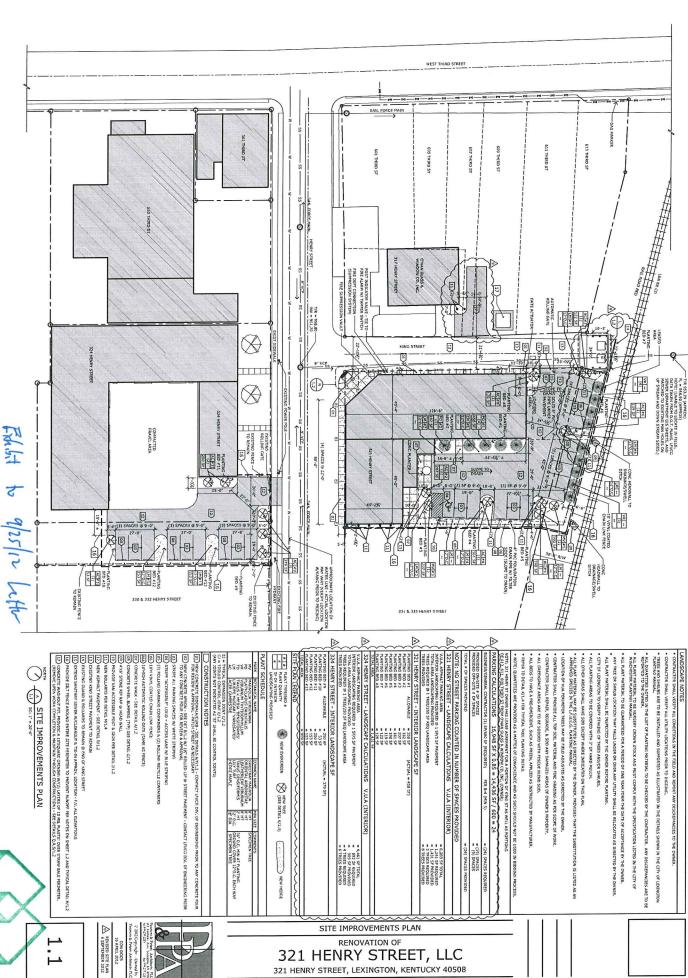
