Third, the Subject Property is encumbered by a twelve foot wide easement for the maintenance of public sanitary sewer granted to LFUCG by Plat, filed for record in Plat Cabinet H, Slide 26, in the Office of the Fayette County Clerk;

Fourth, a portion of the twelve foot wide sanitary sewer easement running West to East in the Southwest portion of the Subject Property, as shown on the Plat, is no longer needed for sanitary sewer purposes;

Fifth, the portion of the easement to be released is more particularly described on the attached Exhibit "A" and shown on the attached Exhibit "B"; and

Sixth, the purpose of this Release of Easement is to release said unneeded portion of the twelve foot wide sanitary sewer easement.

AGREEMENTS:

In consideration of the foregoing recitals, the covenants and agreements contained herein, and the mutual benefits to be derived therefrom, the receipt and adequacy of which are hereby acknowledged, LFUCG and Weingarten, intending to be legally bound, agree as follows:

1. LFUCG hereby releases unto Weingarten, its successors and assigns forever, all of LFUCG's right, title, and interest in and to the following described sanitary sewer easement:

Tates Creek Centre, also designated as the Belleau Wood Shopping Center, Lot 9, Block "A," 4101 Tates Creek Centre Drive, Lexington, Fayette County, Kentucky, as more particularly described on Exhibit "A" attached hereto and incorporated herein by this reference, and as illustrated on Exhibit "B," attached hereto and incorporated herein by this reference.

Being a portion of the same property conveyed to Weingarten Realty Investors by deed dated March 1, 2004, of record in Deed Book 2439, Page 48, in the Office of the Fayette County Clerk.

PROVIDED, HOWEVER, LFUCG hereby specifically retains its right, title, and interest in and to all other sanitary sewer easements as shown on the Plat (Plat Cabinet H, Slide 26), unless previously released in the Office of the Fayette County Clerk.
