

AN ORDINANCE PURSUANT TO SECTION 6.12 OF THE CHARTER OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO REORGANIZE AND RESTRUCTURE A DIVISION, AS FOLLOWS: RENAMING THE DIVISION OF CENTRAL PURCHASING AS THE DIVISION OF PROCUREMENT AND AMENDING THE CLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF DIRECTOR OF PURCHASING, GRADE 531E, AND CREATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF DIRECTOR OF PROCUREMENT, GRADE 531E, RECLASSIFYING THE INCUMBENT, ABOLISHING TWO (2) CLASSIFIED CIVIL SERVICE POSITIONS OF BUYER SR., GRADE 521E, AND CREATING TWO (2) CLASSIFIED CIVIL SERVICE POSITIONS OF PROCUREMENT OFFICER SR., GRADE 521E, RECLASSIFYING THE INCUMBENTS, ABOLISHING THREE (3) CLASSIFIED CIVIL SERVICE POSITIONS OF BUYER, GRADE 517E, AND CREATING THREE (3) CLASSIFIED CIVIL SERVICE POSITIONS OF PROCUREMENT OFFICER, GRADE 517E, RECLASSIFYING THE INCUMBENTS, AND TRANSFERRING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF MINORITY PROGRAM COORDINATOR, GRADE 525E, AND ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF ADMINISTRATIVE SPECIALIST, GRADE 516N, AND THE INCUMBENTS IN THOSE POSITIONS, ALL IN THE DIVISION OF PROCUREMENT; AND FURTHER AMENDING THE CLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH, AS FOLLOWS: CREATING ONE (1) POSITION OF REVENUE COMPLIANCE ANALYST, GRADE 518N, IN THE DIVISION OF REVENUE; CREATING ONE (1) POSITION OF COMPUTER ANALYST, GRADE 521E, ABOLISHING ONE (1) POSITION OF TELECOMMUNICATIONS SUPPORT SPECIALIST, GRADE 516N, AND ABOLISHING ONE (1) POSITION OF NETWORK SYSTEMS ADMINISTRATOR SENIOR, GRADE 524E, ALL IN THE DIVISION OF COMPUTER SERVICES; ABOLISHING ONE (1) POSITION OF SKILLED TRADES WORKER, GRADE 515N, IN THE DIVISION OF STREETS AND ROADS; ABOLISHING ONE (1) POSITION OF ADMINISTRATIVE SPECIALIST SENIOR, GRADE 518N, IN THE DEPARTMENT OF LAW; ABOLISHING ONE (1) POSITION OF ADMINISTRATIVE OFFICER, GRADE 523E, IN THE DEPARTMENT OF PUBLIC SAFETY; CREATING FOUR (4) POSITIONS OF SAFETY OFFICER, GRADE 515N, AND ONE (1) POSITION OF VICTIM'S ADVOCATE, GRADE 518N, ALL IN THE DIVISION OF POLICE; ABOLISHING ONE (1) POSITION OF NUISANCE CONTROL OFFICER, GRADE 515N, AND CREATING ONE (1) POSITION OF CODE ENFORCEMENT OFFICER SR., GRADE 518N, ALL IN THE DIVISION OF CODE ENFORCEMENT; CREATING ONE (1) POSITION OF GRANTS MANAGER, GRADE 524E, IN THE DEPARTMENT OF SOCIAL SERVICES; ABOLISHING ONE (1) POSITION OF PUBLIC SERVICE SUPERVISOR, GRADE 517N, AND CREATING FOUR (4) POSITIONS OF VEHICLE AND EQUIPMENT TECHNICIAN SR., GRADE 519N, FOUR (4) POSITIONS OF VEHICLE AND EQUIPMENT TECHNICIAN PRINCIPAL, GRADE 521N, SEVEN (7) POSITIONS OF HEAVY EQUIPMENT TECHNICIAN SR., GRADE 521N, AND SEVEN (7) POSITIONS OF HEAVY EQUIPMENT TECHNICIAN PRINCIPAL, GRADE 523N, ALL IN THE DIVISION OF FACILITIES AND FLEET MANAGEMENT; ABOLISHING ONE (1) POSITION OF ADMINISTRATIVE SPECIALIST, GRADE 516N, IN THE DIVISION OF HISTORIC PRESERVATION; CREATING ONE (1) POSITION OF AFFORDABLE HOUSING SPECIALIST SR., GRADE 522N, IN THE DIVISION OF GRANTS AND SPECIAL PROGRAMS; ABOLISHING ONE (1) POSITION OF TRADES WORKER, GRADE 510N, ONE (1) POSITION OF PUBLIC SERVICE MANAGER, GRADE 522E, AND ONE (1) POSITION OF INFORMATION OFFICER, GRADE 518N, ALL IN THE DIVISION OF PARKS AND RECREATION; AND AMENDING THE UNCLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH AS FOLLOWS: ABOLISHING ONE (1) POSITION OF ADMINISTRATIVE SPECIALIST SR., GRADE 518N, AND ONE (1) POSITION OF CONSTRUCTION PROJECT ADMINISTRATOR, GRADE 528E, ALL IN THE OFFICE OF THE MAYOR; ABOLISHING ONE (1) POSITION OF CLINICAL SERVICES SUPERVISOR, GRADE 524E, IN THE DIVISION OF COMMUNITY CORRECTIONS; ABOLISHING ONE (1) POSITION OF CLIENT ASSESSMENT COUNSELOR, GRADE 515N, AND ONE (1) POSITION OF JUVENILE PROBATION OFFICER, GRADE 517N, ALL IN THE DIVISION OF YOUTH SERVICES; AND AMENDING THE SWORN AUTHORIZED STRENGTH BY CREATING TWO (2) SWORN POSITIONS OF FIREFIGHTER, GRADE 311N, IN THE DIVISION OF FIRE AND

EMERGENCY SERVICES, ALL EFFECTIVE JULY 1, 2023; AND AMENDING THE CLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH BY REALLOCATING THREE (3) CLASSIFIED CIVIL SERVICE POSITIONS OF FLEET OPERATIONS MANAGER AND THE INCUMBENTS IN THOSE POSITIONS FROM GRADE 523E TO GRADE 527E, REALLOCATING THREE (3) CLASSIFIED CIVIL SERVICE POSITIONS OF FLEET OPERATIONS SUPERVISOR AND THE INCUMBENTS IN THOSE POSITIONS FROM GRADE 520N TO GRADE 525N, AND REALLOCATING TWELVE (12) CLASSIFIED CIVIL SERVICE POSITIONS OF VEHICLE AND EQUIPMENT TECHNICIAN AND THE INCUMBENTS IN THOSE POSITIONS AND VACANT POSITIONS FROM GRADE 516N TO GRADE 517N, ALL IN THE DIVISION OF FACILITIES AND FLEET MANAGEMENT, AND REALLOCATING ONE (1) CLASSIFIED CIVIL SERVICE POSITION OF FLEET OPERATIONS MANAGER, AND THE INCUMBENT IN THAT POSITION FROM GRADE 523E TO GRADE 527E, IN THE DIVISION OF FIRE AND EMERGENCY SERVICES, ALL EFFECTIVE JULY 3, 2023.

WHEREAS, Section 6.12 of the Charter of the Lexington-Fayette Urban County Government provides that the Council shall have the power to “consolidate, divide, and otherwise restructure the organization of all departments, offices and divisions” covered by Article 6 of the Charter; and

WHEREAS, it has been determined that effective and efficient operation of government will occur by renaming the Division of Central Purchasing as the Division of Procurement and reclassifying the incumbents in that division; and

WHEREAS, certain other personnel changes are appropriate based upon the recently enacted FY2024 budget of the Lexington-Fayette Urban County Government.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
