PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the ____th day of August, 2024, by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and, SHEPHERD'S HOUSE, INC. with offices located 635 Maxwelton Court, Lexington, Kentucky 40508, (hereinafter "Organization").

WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

- This Agreement shall include the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:
 - A. Exhibit A RFP #18-2021
 - B. Exhibit B Organization's Response to RFP #18-2024
- 2. Government hereby retains Organization for the period beginning on **July 1**, **2024**, and continuing for a period of two (2) years from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.
- 3. Government shall pay Organization the sum of **One Hundred Thousand 00/100 Dollars** (\$100,000) for Fiscal Year 2025 and **One Hundred Thousand 00/100 Dollars** (\$100,000) for Fiscal Year 2026 for the services required by this Agreement, said services being more particularly described in Exhibits A and B, one-fourth (1/4th) of which

shall be payable in September 2024 or shortly thereafter upon receipt of an **invoice** (for July through December 2024), with one-eighth (1/8th) payable each quarter thereafter upon submission of a quarterly invoice and a detailed quarterly program report. **Quarterly invoices and detailed program reports shall be submitted by January 17th, 2025, April 18th, 2025, July 25th, 2025, October 17th, 2025, January 16th, 2026, and April 17th, 2026. A two-year-end program report shall be submitted by July 24th, 2026.** Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

- 4. In the event of termination of this Agreement by Government as provided for in paragraph 2 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.
- 5. Organization shall perform all duties and services included in Exhibits attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in Exhibits A and Band for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and
- 6. Organization shall indemnify, defend and hold harmless Government, its elected and appointed officials, employees, agents, volunteers, and successors in interest, from and against any and all liability, damages, and losses, including but not limited to:

demands, claims, liens, suits, notices of violation from governmental agencies, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Organization's performance of or breach of this Agreement and/or the provision of goods or services, provided that (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Organization; and (b) not caused solely by willful misconduct of the Government. The Parties understand and agree that the Organization's obligation to defend the Government includes the obligation to investigate, handle, respond to, resist, provide a defense for, and defend claims, at Organization's expense, using attorneys approved in writing by the Government, which approval shall not be unreasonably withheld. The Parties also understand and agree that the Organization's obligation to indemnify includes, but is not limited to: attorney fees and expenses, costs of litigation, court and administrative costs, expert witness fees and expenses, judgments, fines, penalties, interest, all environmental cleanups and remediation costs of whatever kind, and any liability arising from death, injury, or damage of any kind, to any person, including employees and agents of Organization and Government, and damage to, or destruction of, any property, including the property of Government. This provision shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this Agreement. Organization understands that Government is a political subdivision of the Commonwealth of Kentucky and acknowledges and agrees that the Government is unable to provide indemnity or otherwise save, hold harmless, or defend the Organization in any manner.

- 7. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.
- 8. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in Exhibits A & B attached hereto.
- 9. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.
- 10. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

- 11. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.
- 12. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.
- 13. This instrument, and additional documents attached hereto, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.
- 14. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:
 - A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
 - B. Investment Funds Management: The governing board may elect to either:

- (1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or
- (2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

- C. Investment Policies - Safety and Prudence.
 - (1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

- (2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.
- (3) All investments shall be reviewed monthly by a finance or investment committee of the agency.
- (4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.
- D. Audit - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

Request for Proposals

The Lexington-Fayette Urban County Government hereby requests proposals for #18-2024 Community Wellness & Safety – Extended Social Resources (ESR) Grant Program to be provided in accordance with terms, conditions and specifications established herein.

Sealed proposals will be received through Ion Wave until **2:00 PM**, prevailing local time, on **April 25, 2024.** All forms and information requested in RFP #18-2024 must be included and attached in Response Attachments tab in Ion Wave.

Proposals received after the date and time set for opening proposals will not be accepted. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted in Ion Wave before the date and time set for opening proposals.

Proposals, once submitted, may not be withdrawn for a period of one hundred twenty (120) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Signature of this proposal by the Proposer constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

The Lexington-Fayette Urban County Government encourages the participation of minority- and women-owned businesses in Lexington-Fayette Urban County Government contracts. This proposal is subject to Affirmative Action requirements attached hereto.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, religion, sex (including pregnancy, sexual orientation or gender identity), national origin, disability, age, genetic information, political affiliation, or veteran status, and to promote equal employment through a positive, continuing program from itself and each of its sub-contracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;
- (3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and
- (4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers'

representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

- (1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.
- (2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.
- (3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available work-force in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

Contention Process

Vendors who respond to this invitation have the right to file a notice of contention associated with the RFP process or to file a notice of appeal of the recommendation made by the Director of Procurement resulting from this invitation.

Notice of contention with the RFP process must be filed within 3 business days of the bid/proposal opening by (1) sending a written notice, including sufficient documentation to support contention, to the Director of the Division of Procurement or (2) submitting a written request for a meeting with the Director of Procurement to explain his/her

contention with the RFP process. After consulting with the Commissioner of Finance the Chief Administrative Officer and reviewing the documentation and/or hearing the vendor, the Director of Procurement shall promptly respond in writing findings as to the compliance with RFP processes. If, based on this review, a RFP process irregularity is deemed to have occurred the Director of Procurement will consult with the Commissioner of Finance, the Chief Administrative Officer and the Department of Law as to the appropriate remedy.

Notice of appeal of a RFP recommendation must be filed within 3 business days of the RFP recommendation by (1) sending a written notice, including sufficient documentation to support appeal, to the Director, Division of Procurement or (2) submitting a written request for a meeting with the Director of Procurement to explain his appeal. After reviewing the documentation and/or hearing the vendor and consulting with the Commissioner of Finance and the Chief Administrative Officer, the Director of Procurement shall in writing, affirm or withdraw the recommendation.

Affirmative Action Plan

PURPOSE:

Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must

be signed by a duly authorized officer, agent or employee of the Respondent.

- 16. Governing Law: This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
- 17. Ability to Meet Obligations: Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
- 18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
- 19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.
- 20. Contractor [or Vendor or Vendor's Employees] will not appropriate or make use of the Lexington-Fayette Urban County Government (LFUCG) name or any of its trade or service marks or property (including but not limited to any logo or seal), in any promotion, endorsement, advertisement, testimonial or similar use without the prior written consent of the government. If such consent is granted LFUCG reserves the unilateral right, in its sole discretion, to immediately terminate and revoke such use for any reason whatsoever. Contractor agrees that it shall cease and desist from any unauthorized use immediately upon being notified by LFUCG.

- ESR funds cannot be used to teach, advance, advocate or promote any religion
- · Be located in and/or serve Fayette County residents with ESR funds in Fayette County
- Applying organization agrees to comply with all applicable local, state, and federal laws
- Agencies that are primarily affiliated with, or funded through, an educational institution (e.g., a public or private school or the Fayette County Board of Education) are not eligible to receive funds.

1.0 GENERAL INFORMATION & SCOPE

LFUCG intends to award grants for priority-rated programs and services based on documentation of marginalized client populations and articulated individual and community outcomes. The program should utilize best practices and evidence-based models when engaging, assessing, intervening, and terminating services with underserved population groups.

2.0 GENERAL PROVISIONS

2.1 Purpose

The LFUCG is accepting applications from qualified non-governmental, non-profit agencies with current 501(c)3 tax exempt status and with a physical business or program site location in Fayette County (hereinafter, referred to as "Applicant") for ESR funding for FY2025 & 2026 (July 1, 2024 – June 30, 2026). This funding is intended to support agency programs which respond to the funding priorities established herein. THIS FUNDING IS NOT INTENDED TO SUPPORT GENERAL AGENCY OPERATIONS, other than overhead required to support the subject program.

2.2 Funding Period

The funding period is from July 1, 2024 through June 30, 2026.

2.3 ESR Grant Informational Workshop

The Department of Social Services conducted a meeting on March 26th, 2024 that provided potential proposers with an overview of the proposal and review process, instructions on completing the RFP, and presentation of funding priorities.

2.4 Proposal Submission

All Submissions must be uploaded to the LFUCG procurement website at https://lexingtonky.ionwave.net by April 25th, 2024 before 2:00 PM EST. The Submission shall include an enclosed form that shall contain the required documents, and respond to one or more established funding priorities.

Proposal submissions containing significant omissions of required information will be considered nonresponsive and removed from the RFP funding process on the application deadline date (April 25th, 2024). Significant missing responses to questions constitute an incomplete application. The final decision regarding application completeness and penalties will be determined by the LFUCG Division of Procurement in consultation with the Commissioner of Social Services. All proposals must be written in a clear and concise manner, as there will be no follow-up or clarifications to proposer's Proposal Submittal Form once the evaluation process begins.

ask questions or seek clarification regarding the RFP. Attendance is NOT required in order to submit a proposal and will not affect scoring during the evaluation process.

Completed proposals must be submitted **no later than 2 PM on Thursday, April 25th, 2024,** and late or incomplete proposals will not be accepted or evaluated.

The LFUCG intends to conduct proposal evaluation in April and May 2024 immediately following the proposal due date, with the intention to make funding announcements approximately in late May, 2024. This timeline is subject to change without notice.

Successful applicants shall be contacted to negotiate a funding agreement with expectations that an award be in place for the funded programs to begin operations by July 1, 2024. 3.2 Evaluation

Proposals will be evaluated by a neutral panel including LFUCG staff and third-party reviewers who have expertise in the field of human services. The feasibility and need in the community of the programming proposed will be assessed, and financial proposals will also be reviewed at this stage. If a proposal fails to meet the minimum criteria outlined in this RFP, it will be eliminated from further consideration. LFUCG reserves the right to reject any and all proposals. The scoring criteria are outlined in Section 5.0 Criteria.

Upon receipt of submittals, an initial review will take place to ensure that all submissions meet the minimum qualifications and requirements. Proposals shall be completed in all respects as required by this RFP. A Proposal may be rejected if it is incomplete, contains any alterations or other irregularities of any kind, and will be rejected if any such defect or irregularity can materially affect the quality of the information. A Proposal which contains false or misleading statements may be rejected. 5.1 Program Proposal & Design

5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

The Kentucky Office of Drug Control Policy (ODCP) has been tracking overdose deaths in Kentucky since 2013. According to ODCP reports, overdose deaths have been trending upwards in Kentucky since 2012, despite a temporary drop in 2018. Overdose deaths rose 49 percent in 2020 and 14.5 percent in 2021. In 2021, there were 2,250 overdose deaths in Kentucky. In 2022, Fayette County had the second highest number of drug overdose deaths with Fentanyl identified through toxicology in Kentucky. More addiction treatment recovery beds are needed in Fayette County to serve this at-risk demographic. Individuals seeking long-term treatment are trying to not return to environments associated with their addiction. SUDs typically occur co-morbidly with other mental health disorders. Both require treatment for complete recovery. With AODE-residential and Intensive Outpatient licensure the Shepherd's House offers both low-cost addiction treatment and mental health services. The homeless and low-income demographics are underserved in accessing treatment for co-occurring disorders (COD).

Shepherd's House provides long-term residential recovery to adult men (18+) presenting with SUD. Over the past two years, 20% present with COD, without the Shepherd's House program 94% report being food insecure, 96% consider themselves as homeless or unstable housing, and 84% are justice impacted. 38% of our program referrals come from Fayette County Specialty Courts. We provide residents with mental health services and SUD treatment. Our clinical staff includes a Licensed Clinical Social Worker, Target Case Manager, and multiple Adult Peer Support Specialists.

5.1.2 Service Delivery Model

Services are delivered by licensed clinical staff. Intake screenings and needs assessments are administered (60 to 120 minutes) specific to mental health and SUD diagnoses. Once needs are assessed, then individual treatment plans are created using evidence-based practices specific to each client's diagnosis. Treatment plan development is an additional 60-minute session.

During the first 90 days, clients receive the most intensive treatment, including one to three, individual, 60-minute psychotherapy sessions weekly with a counselor, and four, 60-minute group therapy sessions weekly. Months 4-6, clients receive one 60-minute individual session with a counselor weekly and one 60-minute group therapy session weekly. Months 7-12, clients receive two 60-minute individual sessions per month and one group therapy session weekly. Additional sessions are added if necessary to help facilitate each client's treatment goals. Treatment modalities include trauma-informed evidence-based practices including CBT, DBT, psychotherapy, and psychoeducation. All clients participate in Moral Reconation Therapy, an evidence-based cognitive behavioral intervention.

This structured therapy model allows our clinical staff to provide additional evidenced-based support to the group creating a therapeutic community, which is essential to effective out-patient treatment. Throughout each week, Adult Peer Support Specialists offer mutual support through their lived experience. TCMs are essential to providing clients with community resources for reintegration and connecting them to resources including those needed to acquire and maintain employment, budgeting, additional education (GED), and conflict resolution. These learning experiences reduce recidivism, thereby reducing the burden on Fayette County Courts and Jail.

5.1.3 Client Eligibility and Requirements

Adult males (18+) with 30 days of sobriety who pass a drug screen are eligible. Clients are drug tested weekly and must maintain sobriety; complete daily and weekly assigned tasks; follow therapeutic requirements of their treatment plans; participate in abstinence-based recovery (12-steps, Dharma, SMART) and secure a sponsor. Once employed each client begins paying \$125.00 per week. This covers all expenses including room & board, food, utilities, internet, and treatment. Clients must maintain employment absent physical or mental disabilities or limitations. Accommodations are made for any disabilities.

All residents receive services weekly. Even when a relapse occurs, we provide referrals to residents and may allow them to return after 30 days of treatment. Persons who have been justice impacted have long been discarded by society. We believe there are no throwaways. If a man has a desire to get better and poses no threat to our community, the Shepherd's House will continue to allow them back into our program.

Most men arrive unemployed and homeless. Over the past two years, 18% have completed our 12-18 months program. The average length of stay was 173 days. There has been a lot of recovery capital created in the past two years. Many men arrive with no resources. ESR eases this burden by paying the first month's rent (\$500) for 25 new clients, provides full scholarships, for four (4) men referred from Fayette County Specialty Courts (38% of our referrals), and provides scholarship funds for intake fee (\$250) for 25 men.

5.1.4 Evidence-Based/Best Practice

Shepherd's House provides a Trauma-Informed, Recovery-Oriented System of Care (TI-ROSC). SUD is often a symptom of unresolved trauma and pain. We provide evidence-based, comprehensive, holistic, wrap-around services that includes mental health treatment. If a client requires a higher level of care than we are able to provide, we refer them to other community partners for an assessment.

Adult Peer Support Specialist (APSS) is a evidence-based support tool providing lived experiences to those recovering. Substance Abuse and Mental Health Services Administration (SAMHSA) holds peer support as a powerful tool in helping those in recovery feel accepted, validated, and not alone. Alongside professional treatment, SAMHSA suggests peer support boosts empowerment; increases confidence; offers hope; reduce hospitalizations and criminal justice involvement; reduces substance abuse and relapse.

Other evidence-based practices used with clients include: MORAL RECONATION THERAPY: Evidence-based CBT intervention proven to reduce relapse and recidivism by increasing moral reasoning. MRT includes group and individual counseling using structured group exercises and prescribed homework assignments. HAZELDEN' S A NEW DIRECTION: Evidence-based program guiding participants into recovery from SUD and desistance from crime using CBT; c) NURTURING PARENTS and d) 24/7 DAD: evidence-based fatherhood programs.

The Shepherd's House remains open to other curriculum if recommended by our clinical director or other community partners.

Shepherd's House's whole-man treatment approach provides tools for success in life and recovery. We strive for men to live their best lives. Our services are targeted to equip clients to live life on life's terms, and navigate daily ups and downs without using drugs, alcohol, or process addictions as a coping mechanism. We provide life tools for fostering good mental health for those in early recovery and offer additional therapies, including parenting skills.

Successful clients will transition during their residency at Shepherd's House: 1) from housing insecure and unemployed to secured housing and employed; 2) from fiscally irresponsible to current on all financial obligation; 3) from absent, justice impacted, or abusive into a nurturing person; 4) from probation or parole to no supervision without additional incarceration; 5) completion of the 12-steps; 6) participating in community service; 7) consistently treating their mental health issues through psychotherapy and/or medications. These tasks, within the throes of addiction, can't be accomplished. Our goal is to eliminate barriers and help our men recover from addiction.

In 2022 and 2023, 20% of the men who walked through our front door completed the program. The average length of stay was 173 days. In 2020 and 2021, the average length of stay was 63 days. We believe this is proof our program continues to improve and a lot of recovery capital is being created in a man living with us, under our program guidelines, for 6 months, even if they do not complete the 12-18 month program.

5.2.2 Client Empowerment & Community Impact

Through participating in the Shepherd's House program clients can experience a total metamorphosis in cognitive processing and behavior. Many have chronic SUD-related medical conditions which are improved by living in a sober community with like-minded individuals. 84% of our clients are justice-impacted. Within 30 days of admission, clients secure employment and are no longer housing insecure. At 90 days, most are re-establishing family relationships and learning fiscal responsibility. A program requirement is to become current on child support and court ordered obligations. This is new thinking for clients who came into our program reliant on government aid.

The average daily incarceration rate in Kentucky is \$66 or \$24,000 annually. Those with SUD encompass 85% of those incarcerated. They're disproportionately people of color and living below the poverty level, the homeless/houseless, and uneducated. Annual US healthcare costs alone, for addiction, is \$207 Billion. The cost to Fayette County to rehabilitate 100 men annually at the Shepherd's House is zero. Our residents become gainfully employed and taxpaying citizens. They gain self-respect, hope, and the possibility of a different tomorrow. They support their families and avoid the justice system. In 12 months, if 10 justice impacted men live with us and avoid incarceration, the cost saved to the community would be approx. \$240,000. In the past 2 years, based on the average stay of 173 days, the Shepherd's House has saved Kentucky taxpayers approx. \$1,800,000 in incarceration fees alone.

The effectiveness of the program is measured through data collection and client surveys. The measurement tool is preand post-test standardized questionnaires. Questions on topics such as duration of sobriety; basic life skills; employment; current legal circumstances; 12-step engagement; status of family relationships; living situation; financial status. This provides an overall view of a client's quality of life.

Additional data is collected through client engagement during their participation in the program. Client surveys are recommended after 3 months and 6 months of services in the program. We determine the sustainability of success of the program by requesting clients answer the same questionnaire at one, three, and five-years post-Shepherd's House program completion. We do our best to stay in touch with individuals who complete our program and those who leave early. Data collected helps determine if modification, adjustment, or redirection of the content is needed. Also, in what areas we must offer additional resources based on the data.

In the past two years, the sample size is approximately 180 men. Based on this sample size, 20% completed the program. Again, the average length of stay was 173 days. The Shepherd's House believes there is a lot of success and return on investment to Fayette County in the time these men participated in our program. For many, the is the first time they have remained sober, for six months consecutively, in many years.

Jerod Thomas, M.Ed., CADC, is CEO. Facilitates mental health therapy groups and interventions.

Tanith Wilson, CADC, has a dual Masters in Mental Health Counseling and Addiction Counseling. A former Court of Justice Drug Court Recovery Coordinator. She is our Clinical and Compliance Director. As Clinical Director, she oversees all evidence-based programming, facilitates groups, psycho-educational, and family education classes.

Jessica Elliott is a Targeted Case Manager. She completed the IOP program in Danville and came to work full-time at the Shepherd's House in 2022.

Keeley Chaffin, CSW, is a clinical social worker pursuing her LCSW. She has been the lead clinician in this program for the past 12 months.

Andrew Massa and Michael Harper are Two Adult Peer Support Specialists. These individuals offer wrap-around support and services to improve the overall client mental and physical health outcomes.

Shepherd's House is a collaborative effort partnering with multiple local agencies to improve community wellness and safety. 38% of our program referrals come from the Fayette County Specialty Courts (Drug, Veterans, and Mental Health). Lexington-Fayette Health Department and Harm Reduction Services Team provides naloxone training for all facilities, staff, and clients. LFUCG provides medical care including vaccines and testing for illnesses historically prevalent in populations with histories of SUD and/or incarceration. Kentucky Career Center assists our clients with employability skills, workshops, support services, work-based learning opportunities, and securing employment. Job Sustainability is enhanced through weekly training sessions with The Jobs Guy. The Ridge provides MAT including buprenorphine, when prescribed, for our clients. Fayette County benefits from Shepherd's House's long-term treatment solutions for men with SUD/COD because our program participants become tax paying citizens, are no longer justice impacted, reduce recidivism, and reunite with their families.

Shepherd's House is governed by a Board of Directors, each directly impacted by addiction. They possess a variety of skills and professional backgrounds. Board meetings are bi-monthly. Staff and board members frequently communicate outside of board meetings.

Primary funding sources are one annual fund-raiser (Run for Recovery), private donations, and fees for services. The Shepherd's House portion of the funding for this RFP is allocated through its sources.

The Shepherd's House is non-discriminatory. Through intentional and responsible leadership, we recruit, hire, train and promote all positions regardless of race, ethnicity, national origin, religion, sex, physical disability, age, sexual orientation, or status as a disabled veteran. We provide monthly anti-bias and anti-racist training for our staff and clients. We seek funding to underwrite the cost of removing hate-speech tattoos. Clients who've served prison sentences may have developed prison gang mentality (some ethnically charged, others rooted in vile white supremacy). We seek to eliminate those prejudices which are barriers to treatment and to our community. Shepherd's House is a licensed residential and intensive out-patient Alcohol and Other Drug Entity in Kentucky certified by OIG. People with SUD/COD encompass the spectrum of race, ethnicity, orientation, and income, but overdose rates in black men have particularly increased. For clients not proficient in English we utilize local resources including interpreting services to bridge language barriers and provide equal services. We strive to meet racial equality & equity goals in our hiring practices.

Upon entering our program, 96% of Shepherd's House clients are homeless and 94% are food insecure. We eliminate transportation as a barrier by providing transportation to clients to/from medical, therapy appointments and recovery meetings. We feel our program is a win/win/win for the Individual, their families, and the Fayette County community.
