B. Special Public Safety Committee Update & Public Safety Committee Update

These updates were given by Chair CM Diane Lawless. In the Special Public Safety Committee meeting the discussion was about the best systems/ practices for running the jail. This issue will be heard again in March. The discussion in the regular Public Safety Committee meeting was about the taxi cab ordinance, which was approved by the committee to continue to a future Public Safety Committee meeting. Also, discussed in this meeting was the Emergency Management Long Range Strategic Plan which was presented by Pat Dugger. There was a PowerPoint available for review. No motions came from either meeting.

C. Living Arts & Science Center Capital Project Presentation

This presentation was given by Heather Lyons from The Living Arts & Science Center and Phil Holoubek. Several CMs asked question about the project, where the money was coming from, how were the participating schools chosen, how the different counties that were participating were targeted, etc. Mr. Holoubek stated that there would be 5 key areas of interest: a planetarium, digital media studio, recording arts studio, children's gallery, and a teaching kitchen. Some CMs volunteered their services to make calls on the Center's behalf or whatever is needed.
