The Lexington-Fayette Urban County Government is accepting quotes to establish a price contract for Graphic Vinyl Wraps for Collection Trucks for the Division of Waste Management, 675 and 699 Byrd Thurman Drive, Lexington, KY, as per the following specifications.

#### **Specifications:**

- Truck wraps will be high-quality, permanent all-weather vinyl and the only acceptable material for the vinyl is as follows:
  - 3M-IJI180Cv3 Wrap vinyl w/ compatible UV overlaminate
  - o Avery MPI 1105 Super Cast Easy Apply RS w/ compatible UV overlaminate
  - Orafol Orajet 3751 RA w/ compatible UV overlaminate
- Pricing submitted should be UOM in square feet for vinyl, installation and removal of old graphics.
- The Division of Waste Management receives various truck types at different periods throughout a fiscal year, so vendor will provide graphics and installation to any truck type as needed throughout the duration of the one-year agreement and the automatic one-year renewal period.
- Trucks will be washed prior to installation; any ladders or other objects will be removed for installation.
- In the event of bad weather, indoor installation space is available in most situations. If cold conditions are expected, trucks can be placed indoors the evening prior to installation in order to provide ideal conditions for graphics installation.


