AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) CLASSIFIED POSITION OF CUSTODIAL WORKER, GRADE 506N, IN THE DIVISION OF AGING & DISABILITY SERVICES; ABOLISHING ONE (1) CLASSIFIED POSITION OF VEHICLE AND EQUIPMENT TECHNICIAN, GRADE 517N, AND ABOLISHING ONE (1) CLASSIFIED POSITION OF HEAVY EQUIPMENT TECHNICIAN, IN THE DIVISION OF FACILITIES AND FLEET MANAGEMENT; ABOLISHING ONE (1) CLASSIFIED POSITION OF PLUMBING ASSISTANT , GRADE 515N, IN THE DIVISION OF PARKS AND RECREATION; ABOLISHING ONE (1) UNCLASSIFIED POSITION OF ADMINISTRATIVE AIDE TO MAYOR SENIOR, GRADE 524E, IN THE OFFICE OF THE MAYOR; TRANSFERRING ONE (1) CLASSIFIED POSITION OF RECREATION SUPERVISOR, GRADE 514N, FROM THE DIVISION OF PARKS AND RECREATION TO THE DIVISION OF COMMUNITY AND RESIDENT SERVICES, AND TRANSFERRING THE INCUMBENT; CHANGING THE CLASSIFICATION TITLE OF ONE (1) CLASSIFIED POSITION OF INFORMATION SYSTEMS MANAGER, GRADE 529E, AND THE INCUMBENT, TO HYBRID CLOUD SERVICES MANAGER, IN THE DIVISION OF COMPUTER SERVICES; AND CHANGING THE CLASSIFICATION TITLE OF ONE (1) CLASSIFIED POSITION OF PLAYGROUND SAFETY INSPECTOR, GRADE 517N, AND THE INCUMBENT, TO RECREATION FACILITIES TECHNICIAN, GRADE 517N, IN THE DIVISION OF PARKS AND RECREATION, ALL EFFECTIVE RETROACTIVE TO JULY 1, 2026.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
