

PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the 26th day of July MONTH 2021, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and **GOD'S PANTRY FOOD BANK**, with offices located **1685 JAGGIE FOX WAY, LEXINGTON KY 40511**, (hereinafter "Organization").



WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

1. Government hereby retains Organization for the period beginning on **July 1, 2021**, and continuing for a period of one (1) year from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.

2. Government shall pay Organization the sum of **\$295,000** for the services required by this Agreement, said services being more particularly described in the Addendum attached hereto and incorporated herein by reference as Exhibit A, one-half (1/2th) of which shall be payable in September 2021 or shortly thereafter upon receipt of an invoice, with one-half (1/2th) payable in January 2022 or shortly thereafter upon receipt of an invoice and the first six month detailed program report., **The first invoice required by this section shall be submitted by September 17th, 2021. The second invoice and the first six month detailed program report shall be due January 21st 2022. A detailed program report shall be submitted by April 15th, 2022. A year-end program report shall be submitted by July**

22nd, 2022. Failure to submit the April 2022 program report and the July 2022 year-end program report shall result in the Organization repaying one-half (1/2th) of total funds provided under this Agreement. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

3. In the event of termination of this Agreement by Government as provided for in paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.

4. Organization shall perform all duties and services included in the Addendum attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in the Addendum and for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and

5. Organization shall indemnify, defend and hold harmless Government, its officers, agents and employees, from and against any and all liabilities, claims, demands, losses, damages, costs, and/or expenses arising out of, from, relating to, and/or based on the Organization's violation of any such laws, ordinances or regulations or Organization's breach of this Agreement.

6. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.

7. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in the addendum attached hereto.

8. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.

9. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

10. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

11. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.

12. This instrument, and the Addendum incorporated herein, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.

13. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:

- A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
- B. Investment Funds Management: The governing board may elect to either:

(1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or

(2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

C. Investment Policies - - Safety and Prudence.

(1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

(2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.

(3) All investments shall be reviewed monthly by a finance or investment committee of the agency.

(4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.

D. Audit - - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

Request for Proposal

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #12-2021 Food Insecurity & Nutritional Access – Extended Social Resources (ESR) Grant Program** to be provided in accordance with terms, conditions and specifications established herein.

Proposals will be received **online only** at <https://lexingtonky.ionwave.net> until **2:00 PM**, prevailing local time, on **May 14, 2021**.

Proposals received after the date and time set for opening proposals will not be considered for award of a contract/grant. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted online before the date and time set for opening proposals.

Additional copies of this Request For Proposals are available from the Division of Central Purchasing, Room 338 Government Center, 200 East Main Street, Lexington, KY 40507, (859)-258-3320, at no charge.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Electronic signature online at <https://lexingtonky.ionwave.net> constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Pre-Proposal Meeting will be held on **April 30th, 2021 at 10:00AM EST** via Zoom (see section 3.1 in Scope of Work document for meeting link).

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and to promote equal employment through a positive, continuing program from itself and each of its subcontracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;

(3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and

(4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

(1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.

(2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the

contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available workforce in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

AFFIDAVIT

Comes the Affiant, Michael J. Halligan, and after being first duly sworn, states under penalty of perjury as follows:

1. His/her name is Michael J. Halligan and he/she is the individual submitting the proposal or is the authorized representative of God's Pantry Food Bank, Inc. the entity submitting the proposal (hereinafter referred to as "Proposer").
2. Proposer will pay all taxes and fees, which are owed to the Lexington-Fayette Urban County Government at the time the proposal is submitted, prior to award of the contract and will maintain a "current" status in regard to those taxes and fees during the life of the contract.
3. Proposer will obtain a Lexington-Fayette Urban County Government business license, if applicable, prior to award of the contract.
4. Proposer has authorized the Division of Central Purchasing to verify the above-mentioned information with the Division of Revenue and to disclose to the Urban County Council that taxes and/or fees are delinquent or that a business license has not been obtained.
5. Proposer has not knowingly violated any provision of the campaign finance laws of the Commonwealth of Kentucky within the past five (5) years and the award of a contract to the Proposer will not violate any provision of the campaign finance laws of the Commonwealth.
6. Proposer has not knowingly violated any provision of Chapter 25 of the Lexington-Fayette Urban County Government Code of Ordinances, known as "Ethics Act."

7. Proposer acknowledges that "knowingly" for purposes of this Affidavit means, with respect to conduct or to circumstances described by a statute or ordinance defining an offense, that a person is aware or should have been aware that his conduct is of that nature or that the circumstance exists.

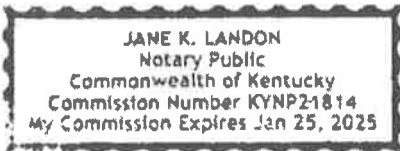

EQUAL OPPORTUNITY AGREEMENT

The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

The Contractor will not discriminate against any employee or applicant for employment because of physical or mental disability.

- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment Opportunity, states:

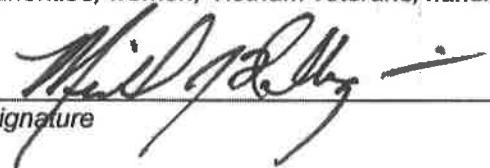
The Secretary of Labor may investigate the employment practices of any Government contractor or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have been violated.

The Lexington-Fayette Urban County Government practices Equal Opportunity in recruiting, hiring and promoting. It is the Government's intent to affirmatively provide employment opportunities for those individuals who have previously not been allowed to enter into the mainstream of society. Because of its importance to the local Government, this policy carries the full endorsement of the Mayor, Commissioners, Directors and all supervisory personnel. In following this commitment to Equal Employment Opportunity and because the Government is the benefactor of the Federal funds, it is both against the Urban County Government policy and illegal for the Government to let contracts to companies which knowingly or unknowingly practice discrimination in their employment practices. Violation of the above mentioned ordinances may cause a contract to be canceled and the contractors may be declared ineligible for future consideration.

GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, 29 U.S.C. 650 *et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.
4. Proposal Reservations: LFUCG reserves the right to reject any or all proposals, to award in whole or part, and to waive minor immaterial defects in proposals. LFUCG may consider any alternative proposal that meets its basic needs.
5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.
6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted

to bribe an officer or employee of the LFUCG.

9. **Additional Information:** While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
10. **Ambiguity, Conflict or other Errors in RFP:** If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. **Agreement to RFP Terms:** In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract/Grant under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
12. **Cancellation:** If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.

- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
- (a) Failure to perform the contract according to its terms, conditions and specifications;
 - (b) Failure to make delivery within the time specified or according to a delivery schedule fixed by the contract;
 - (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
 - (d) Failure to diligently advance the work under a contract for construction services;
 - (e) The filing of a bankruptcy petition by or against the contractor; or
 - (f) Actions that endanger the health, safety or welfare of the LFUCG or its citizens.

B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. 14. **No Waiver:** No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and

authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must be signed by a duly authorized officer, agent or employee of the Respondent.

16. **Governing Law:** This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
17. **Ability to Meet Obligations:** Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

5.1 Program Proposal & Design

5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

Food insecurity exists in every zip code of Fayette County. In every part of our community someone, or a whole family of someones, is unable to buy, borrow, or access enough food for every member of their household to sustain an active and healthy life.

Of Lexington's 318,734 residents, Feeding America's 2018 Map the Meal Gap indicates 12.7% are food insecure. This means at some point—perhaps daily or monthly, perhaps three times per year—more than 40,400 Lexington neighbors do not have enough food for themselves or others in their home.

God's Pantry Food Bank (GPFB) has operated the Fayette County Pantry Program (FCPP) since 1955. What was once a small-scale volunteer effort is now a coordinated network of organizations and individuals working together to provide at least five days' worth of groceries to any Fayette County resident who needs food. Hunger in our community is not limited to one population. A family suffering from a job loss due to COVID-19 may need help four times; a senior citizen living on a fixed income may need help every month. The FCPP exists to fill that need.

As other circumstances change, having a reliable food safety net for our neighbors is necessary. We estimate between 1,800 and 2,000 families will request a pantry visit each month in FY22. The COVID-19 pandemic and its related impact made it clear: this program is critical and the community—both those in need and those who want to help—expect it to continue.

5.1.2 Service Delivery Model

The solution to food insecurity is food access. The Food Bank's model changed in March 2020 to accommodate COVID-19 safety precautions, but service never stopped.

As of May 14, 2021, GPFB operates drive through, contactless pantry service at three locations: Central Christian Church, Community Action Council (Cambridge location), and St. Luke United Methodist Church. Clients receive two pre-packed boxes of shelf-stable items, plus fresh produce, bread, and frozen meat. Our intention is to return to our previous model where volunteers assist clients as they make choices from a selection of products. However, COVID-19 concerns have delayed that at least until September 2021.

A unit of service is a pantry visit, whether via drive through or shopping model. Currently, each household may visit a pantry up to twice per month. This may adjust to one visit per month at some point in FY22. Pantries are housed in partner organizations (churches or nonprofits) and staffed by volunteers. Each pantry has slightly different hours, but at least one pantry is open every weekday between the hours of 1 p.m. and 6:30 p.m., to accommodate as many clients and schedules as possible.

Nutritious food is an important piece of the delivery model. Every household receives canned fruits and vegetables, fresh produce, canned soup, grains, milk, meat, and other proteins. Our goal is to provide groceries that encourage and support a healthy diet. In FY2020 the program provided 2,270,928 pounds of food (1,892,440 meals) for Lexington families. We anticipate at least 22,000 pantry visits in FY22.

5.1.3 Client Eligibility and Requirements

5 Points

To receive food from one of the pantries operated by GPFB, a client must be a resident of Fayette County and complete a qualification intake form. Client surveys primarily determine food insecurity need and household size, but we also collect demographic and health-related data to better understand the client population. An intake form may be completed either through one of our 275+ referring agencies or by calling the GPFB Central Intake line directly. Agency referrals are helpful to assess need so we can focus on sourcing and distributing food, but the influx of new clients as a result of the COVID-19 pandemic in 2020 prompted us to allow "self referrals." This is now our top referring method.

Central intake is open for calls from 9 a.m.-noon and 1-3 p.m. every weekday. Clients may choose the pantry location, day, and time they would like to visit. To ensure the safety of staff, volunteers, and clients, pantry distribution is currently contactless with drive through/curbside pickups. A client may visit a pantry up to two times per month.

Our top referring agency is Community Action Council. This is also the first place we recommend to new clients. At CAC they will meet with an intake specialist who determines potential resource gaps beyond food such as utility, rent, or child care assistance. The next three largest referring agencies are The Nest, Lexington Rescue Mission, and Fayette County Public Schools (at least one staff member at every school may make a referral).

5.1.4 Evidence-Based/Best Practice

All GPFB pantries in Lexington follow a Model Pantry Standard endorsed by Feeding America, the nation's food bank network. The standard includes these guidelines:

- + Provide a space and culture that promotes respect and dignity for clients
- + Offer service at least three days per week
- + Provide five to seven days' worth of food to clients
- + Include items from all the following categories: milk, protein, vegetables, fruits, and grains.
- + Accurately record client information and visits

The Model Pantry Standard also places strong preference on operating with a Client Choice model, where recipients may shop or choose items that best fit their needs. The COVID-19 pandemic and related health concerns required altering the model to protect clients and volunteers, who are a critical piece of the Client Choice method. The goal is to return to that format as soon as site hosts and volunteers are comfortable returning. Even without the Client Choice piece, we have adapted our current model multiple times to improve frequency of service, volume of food, and variety of food.

We also adhere to these best practice recommendations: Maintain a Board of Directors, 501c3 status, a strategic plan, organization goals and objectives, an annual budget, and appropriate stakeholder engagement. Our stakeholders include more than 275 Fayette County partners that may refer clients for a pantry visit. By connecting with diverse populations, including school-age children, refugees, veterans, and other groups, we work to ensure food access for every member of our community.

5.2 Program Measures & Evaluation

5.2.1 Service Efficacy & Desired Outcomes

GPFB’s service philosophy is that we want every Lexington resident to have enough food to provide healthy meals for every member of their household. If they are unable to do that on their own, our goal is to help. We eliminate obstacles to food security, whether for two months or as long as they need assistance.

Beyond simply making food available, GPFB makes strategic choices to increase food security in the community. Placement of pantries throughout Fayette County based on user addresses and robust partnerships with other agencies are among the purposeful decisions the organization makes to maximize access.

GPFB has specific goals for the program. First, is to give a family enough food per pantry visit to create at least a five days’ worth of meals for every member of the household. Another priority is providing nutritious items from all the major food groups: fruits, vegetables, meat/protein, dairy, and grains. In that respect, if a client leaves with a grocery cart or a car full of food we have achieved success.

We hope to maintain and grow the volume and quality of food available to Lexington families through this program. However, our philosophy also emphasizes cost efficiency in our services. Both demand and the cost of food have increased in the last 14 months.

Success is a mix of sharing a sense of hope with our clients, a personal touch at the pantry, and providing the dignity that comes with serving yourself or a your family a healthy meal.

5.2.2 Client Empowerment & Community Impact

Without proper nutrition, a person cannot survive. With a balanced diet, a person obtains fuel needed to accomplish tasks from building bones to regulating heartbeat. Without fuel, there is no energy, and only negative results, from headache and dizziness in the short term to significant health issues and even death in the long term.

This is elementary but fundamental to explaining the work of the pantry program. We focus on one crucial thing: food. GPFB sources food, acquires food, raises money to buy food, accepts donated food, advocates to allow clients access to more food, and distributes food.

Without food, getting out of bed may be difficult, so becoming a student, parent, caregiver, co-worker, or friend is nearly impossible. From a physical aspect, moving a client from hungry to food secure makes it possible for them to hold a steady job, learn in school, care for others, and contribute to the community. In 2020, at least 17,224 unique people from 8,050 households received food from a pantry. This is 5.4% of Lexington residents (a 1% increase from last year) a clear indicator of the program’s impact and value to the community.

The pantries provide food, but they also provide personal confirmation that someone cares, evidenced by the volunteers who look our clients in the eye and offer help.

5.2.3 Data Assessment & Quality Improvement

GPFB collects three sets of data to assess the program and inform improvement. The first is internal data, primarily the number of households served monthly and the poundage of food distributed. Those two data points indicate if clients are receiving the appropriate amount of food at each visit. The second is subjective feedback from staff and pantry volunteers that will be available once we return to our typical client choice model. The third is data from one of two formal methods, Link2Feed and the Hunger in Fayette County Survey.

Mary Alice Daniels oversees the FCPP and uses the Link2Feed database daily to maintain all client records, appointments, and service history. This data shows short and long-term trends which inform food purchases, budgeting, and other adjustments.

In April 2021 we conducted a small-scale survey. A total of 125 clients representing all three pantry locations responded over a five-day period. Its purpose was to solicit feedback on food preferences, transportation, Internet access, and SNAP enrollment.

In 2022 we will undertake the Hunger in Fayette County Survey, the most in-depth data collection tool we have. The survey takes place at all pantries and collects information from 400 clients. It will contain at least 20 questions, plus general demographic information, and solicits feedback on topics like respectful treatment at pantries and types of food available. That data will be evaluated and if necessary, used to adjust program services including pantry access and food selection.

5.3 Capacity & Sustainability

5.3.1 Staff Qualifications & Experience

GPFB has operated Fayette County's largest pantry program in some form since 1955. Responsibility for the FCPP falls under two departments: Programs and Operations.

The Programs Department handles all aspects of the client and volunteer experience. Danielle Bozarth is the Programs and Partner Services Director and has been with GPFB since 1995. She eliminates barriers for the FCPP, troubleshoots, and assists with long-term strategy. Mary Alice Daniels, Programs Community Developer, directly manages all aspects of the FCPP including service model, scheduling, volunteer training, procedures, and partner agencies. She has been in her current role since 2014. She is a licensed certified social worker and worked previously at LFUCG in Youth Services. She has overseen growth in the program and was integral in reworking it quickly in 2020 to ensure service continued even as the COVID-19 pandemic created significant challenges.

Food in the pantries is a combination of donated and purchased product. The Operations Department oversees all aspects of acquiring, tracking, and distributing food from all sources. Elisa Shannon joined the Food Bank as Operations Director in 2020. Elisa oversees FCPP logistics with help from Britt Hensley, Warehouse Manager, and Peter Paterson, Food Procurement Officer. Pantry drivers Nick Phillips, Allen Prigge, and warehouse staff members handle deliveries.

As a member of the Feeding America network of food banks, GPFB has access to best practices, key learnings, and support in every area of programming operations, including food pantry recommendations and COVID-19 safety measures.

5.3.2 Partnership & Resource Leverage

The success of the Fayette County Pantry Program absolutely depends on successful partnerships. The three current distribution sites are hosted by partner organizations with current MOUs in place. A fourth location in an underserved area of Fayette County is slated to open late in 2021. Beyond the physical pantry spaces themselves, this program and GPFB's expertise in food insecurity is a key piece of the comprehensive response in our community. GPFB is the largest organization providing groceries to people facing hunger in our region. We forge partnerships to ensure everyone in need has access to the FCPP, but also, to ensure other programs addressing food insecurity have the resources they need.

GPFB also operates 76 additional programs in Lexington including the Commodity Supplemental Food, Backpack, Kids Cafe, and School Pantry programs that make food available to senior citizens and children. In total GPFB infused 5,234,657 pounds of food into Fayette County in CY2020. All of this work is geared toward providing food security and nutritional access to Lexington residents.

The GPFB board, volunteers, and donors support all our programs at many levels. We do not have committed gifts for the programmatic piece of pantry operations yet for FY22, but we are in the early stages of investing in the long-term growth of the program.

The Fayette County Pantry Program is the cornerstone of the Food Bank's work and our organization invests accordingly. That said, its success has been directly linked with the level of community support it receives.

5.3.3 Outreach & Inclusion Strategy

The FCPP is designed to be available to and accessible by all potential participants, from the number of referring agencies to the facilities that house pantries. Our clients have every kind of mobility challenge, from physical access to transportation, so pantries are in accessible buildings with nearby parking and on bus routes. Pantry hours are designed to accommodate different work and life schedules, are placed strategically throughout Lexington in areas of high need, and are open 27.5 hours per week.

Beyond physical accessibility, both GPFB and the United States Department of Agriculture require that no person in need of food be denied or discriminated against based on race, national origin, religion, or any other distinguishing characteristic. Our data indicates a diverse range of people are accessing our services. Since July 2020, 42% of clients identify as white, 33% as African American, and 14% Hispanic.

We ask that clients make appointments so we can stock and staff distributions accordingly. However, if someone arrives unannounced, they are served with only proof of Fayette County residency required. When we return to a Client Choice model, a system using colored shapes guides shopping choices so we can communicate without reading or speaking English. This accommodates clients who speak other languages or who are hearing impaired.

Still, we recognize gaps in reaching some populations. Non-US residents may be fearful of receiving food due to citizenship status. Transportation and appointments may still present barriers. We are continually reassessing our services with these opportunities in mind.
