Dear Chester:



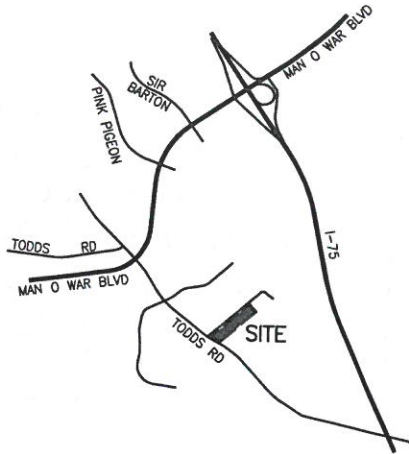
