Being a tract of land lying in Fayette County on the west side of Clays Mill Road, point of beginning being approximately 29 feet north of the intersection of Lamont Drive and Clays Mill Road, and more particularly described as follows:

Beginning at a point 41.40 feet left of Clays Mill Road at Station 137+38.84; thence North 66 Degrees 01 Minutes 27 Seconds West a distance of 4.88 feet to a point 46.28 feet left of Clays Mill Road at Station 137+38.57; thence North 25 Degrees 48 Minutes 56 Seconds East a distance of 69.84 feet to a point 45.96 feet left of Clays Mill Road at Station 138+09.80; thence South 65 Degrees 57 Minutes 34 Seconds East a distance of 8.01 feet to a point 37.96 feet left of Clays Mill Road at Station 138+09.97; thence along an arc 70.00 feet to the right, having a radius of 1,870.00 feet, the chord of which is South 28 Degrees 22 Minutes 19 Seconds West for a distance of 70.00 feet and the POINT OF BEGINNING; and,

The above described parcel contains 0.011 acres (456 sq. ft.) of temporary construction easement; and

Being a portion of the property conveyed to Robert Joseph Sturdivant, II, a single person and Helen Jennifer Grammer, a single person, by deed dated March 12, 2014, of record in Deed Book 3223, Page 109, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project on this land and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have

good right to sell and convey the same as herein done, and that they will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS 382-135(2)(a), this public utility easement is exempt from real estate transfer tax pursuant to KRS 142.050.
