- Choose Existing Verizon Customers and enter in the available field either:
 - Your existing mobile telephone number, or
 - My Verizon user ID.
- Click Log in and Validate.
- Once logged in, click Validate by Email Address.
- Enter the work email address (twice) and click Validate by Email Address.

A confirmation email will be sent to the work email address provided. Click on the link enclosed in the email within 72 hours to complete validation. If not clicked within 72 hours, begin the process over and resubmit the request.

VALIDATE BY PAYSTUB OR OTHER PROOF OF YOUR EMPLOYMENT OR AFFILIATION

- Choose Existing Verizon Customers and enter in the available field either:
 - Your existing mobile telephone number, or
 - My Verizon user ID.
- Click Log in and Validate.
- Once logged in, click Validate by Paystub.
- Complete the customer and employer information on the Employment Validation Form and click Continue.
- Click Choose File to select a paystub or other proof of employment or affiliation.
 - The paystub must be issued within the last 60 days. Please black out any sensitive personal information.
- Click Log in and Validate.
- Click Upload My Paystub.
- After review, a status notification will be emailed.

Employees can register their lines for a 15% discount and receive a 3% bonus discount by enrolling in My Verizon and paperless billing. Discount applies to your Monthly Account Access Fees. 2-yr. line term on eligible Calling Plans \$34.99 or higher required.

To qualify for a discount: You must be an employee or affiliated with an organization that has an agreement with Verizon Wireless. Begin or already have a 2-year contract for your account or participate in the Verizon Edge program. Most voice and data plans with a monthly access fee of \$34.99 or higher qualify for a discount. The Monthly Account Access Fees on MORE Everything Plans are also discountable on plans \$34.99 or higher, but Monthly Line Access Fees are not eligible for discounts. Features added onto your account may be eligible for discounts if the monthly access fees are \$24.99 or higher. Note: Some plans and features are not eligible for discounts and that limitation will be called out in the plan details. Once approved, the qualifying discount will appear within 1 to 2 billing cycles. Please note that periodically we will ask you to validate your current employment or affiliation status.
