
BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute an agreement, which is attached hereto and incorporated herein by reference, awarding a Class A (Neighborhood) Incentive Grant to Tanbark Association of Neighbors, Inc., for stormwater quality projects.

Section 2 – That an amount, not to exceed \$39,925.00, be and hereby is approved for payment to Tanbark Association of Neighbors, Inc., from account #4052 – 303204 – 78112, pursuant to the terms of the agreement.

Section 3 – That this Resolution shall become effective on the date of its passage.

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE CHANGE ORDER NO. 1 (FINAL) TO THE AGREEMENT WITH STANTEC CONSULTING SERVICES, INC., FOR SANITARY SEWER CAPACITY, MANAGEMENT, OPERATIONS, AND MAINTENANCE (CMOM) IMPLEMENTATION SERVICES, DECREASING THE CONTRACT PRICE BY THE SUM OF \$123,619.75, FROM \$275,000.00 TO \$151,380.25.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute Change Order No. 1 (Final), which is attached hereto and incorporated herein by reference, to the Agreement with Stantec Consulting Services, Inc., for Sanitary Sewer Capacity, Management, Operations, and Maintenance (CMOM) Implementation Services, decreasing the contract price by the sum of \$123,619.75, from \$275,000.00 to \$151,380.25.

Section 2 – That this Resolution shall become effective on the date of its passage.
