WHEREAS, the Agreement provides for all amendments to be in writing executed by GOVERNMENT and SUBRECIPIENT;

NOW, THEREFORE, in consideration of the foregoing and mutually agreed upon promises, conditions, and covenants hereinafter set forth, the parties hereto agree as follows:

Article II, "Obligations of the Subrecipient" shall be amended to provide that the SUBRECIPIENT shall expend all grant monies by August 31, 2023.

In all other respects, except as specifically modified herein, the terms of the Agreement dated October 14, 2020, as amended in the First Amendment, shall remain in full force and effect with respect to the provisions outlined therein.
