

AMENDMENT TO AGREEMENT

THIS AMENDMENT TO AGREEMENT, made and entered into on this _____ day of _____, 2017, by and between **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government pursuant to KRS Chapter 67A, and located at 200 East Main Street, Lexington, Fayette County, Kentucky 40507 (hereinafter referred to as "Government"), and **ARBOR YOUTH SERVICES, INC.**, a Kentucky non-profit corporation pursuant to KRS Chapter 273, and whose post office address is 540 West Third Street, Lexington, Kentucky 40508 (hereinafter referred to as "SUBRECIPIENT".)

WHEREAS, Government and Grantee entered into an Agreement dated October 10, 2016 ("Agreement"), in which the SUBRECIPIENT was allocated \$15,800 in federal Community Development Block Grant Program funds (CFDA # 14.218) as provided by the 2016 Consolidated Plan for the purpose of operating a "Drop-In Center" program that will provide outreach, education and aftercare services to homeless youth in Fayette County;

WHEREAS, SUBRECIPIENT has requested an amendment to its scope of work;

WHEREAS, the Agreement provides for all amendments to be in writing executed by Government and Grantee;

NOW, THEREFORE, in consideration of the foregoing and mutually agreed upon promises, conditions, and covenants hereinafter set forth, the parties hereto agree as follows:

1. Article I, "SCOPE OF SERVICES," A. Activities shall be amended to include the following services:

"The SUBRECIPIENT will be responsible for the operation of a Street Outreach Center to provide outreach, education and other services to youth ages 16-24 that are homeless, living on the streets, or at risk of homelessness. The services shall be operated in a manner satisfactory to the GOVERNMENT and in compliance with all local, state, and federal laws and regulations."

2. Article II, "TIME OF PERFORMANCE" shall be amended to include the following:

The term of this Agreement shall be October 1, 2016, through December 31, 2018.

3. Article III, "USE OF FEDERAL FUNDS" shall be amended to include the following:

Community Development Block Grant funds in the amount of \$25,000 may also be used for the purpose of operating a Street Outreach Center program that will provide outreach, education and aftercare services to homeless youth in Fayette County.

In all other respects, except as specifically modified herein, the terms of the Agreement dated October 10, 2016, shall remain in full force and effect with respect to the provisions outlined therein.
