FURTHER, for and in consideration of the aforementioned sum, the receipt and sufficiency of which is hereby acknowledged, Grantors have BARGAINED and SOLD and do hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, the temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

# <u>Temporary Construction Easement</u> (a portion of 1848 Clays Mill Road)

Beginning at a point 56.35 feet right of Clays Mill Road at Station 196+75.26; thence North 29 Degrees 29 Minutes 30 Seconds East a distance of 10.00 feet to a point 57.48 feet right of Clays Mill Road at Station 196+85.19; thence South 1 Degree 18 Minutes 37 Seconds East a distance of 11.64 feet to a point 62.27 feet right of Clays Mill Road at Station 196+74.58; thence North 60 Degrees 30 Minutes 30 Seconds West a distance of 5.96 feet to a point 56.35 feet right of Clays Mill Road at Station 196+75.26 and the POINT OF BEGINNING; and,

The above described parcel contains 0.001 acres (30 sq. ft.) of temporary construction easement; and

Being a portion of the property conveyed to Donna Hampton, a single person and Robert Hampton, a single person, by deed dated June 12, 2009, of record in Deed Book 2881, Page 005, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD the above-described easements together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the

commencement of construction of the project and will expire upon completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, all of their right, title, and interest in and to the property to the extent of the interest conveyed herein, including all exemptions allowed by law, and do hereby covenant to and with the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the same as herein done, and that they will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS 382.135(2), this deed of easement, which conveys a utility easement, need not contain a statement of consideration.
