Maintenance Renewal for OnBase Enterprise License

Overview

Lexington Fayette Urban County Government (LFUCG) acquired a site license for OnBase, originally purchased as LibertyNet document management software in 1999. OnBase has been implemented in multiple departments, including:

OnBase Enterprise Content Management (ECM) software, a product of Hyland Software, is one of the top rated ECM products in the world, with over 12,000 organizations using the software VeBridge, formerly Source Imaging, a Lexington technology company, provides the maintenance, technical support and associated technology services to LFUCG in support of OnBase. VeBridge is a certified OnBase reseller and support provider.

With the implementation of the Accela product for Water Quality, the OnBase and Accela applications were tightly integrated. VeBridge has been the source of several custom integrations. Support for these integrations are included in the annual maintenance fees paid by LFUCG. OnBase provides a robust infrastructure to support true e-government through a long-term enterprise-wide implementation. With OnBase's ability to provide tight integration with other LFCUG core systems, such as PeopleSoft and ESRI, it provides yet another industry-leading knowledge management system to support LFUCG.

Terms of the Renewal

By approving this renewal agreement, LFUCG will renew the annual maintenance fee for 5 years for the currently licensed software modules listed in the table below. If new software modules are added the cost will be adjusted accordingly.
