

**GRANT OF EASEMENT**

This **EASEMENT** is made and entered into this 8 day of November, 2013, by and between **GRANT K. ROBBE and KATHY S. ROBBE**, husband and wife, 189 N. Cleveland Road, Lexington, Kentucky 40509 ("Grantors"), which is also the in-care of tax mailing address for the current tax year, and the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507 ("Grantee");

**W I T N E S S E T H:**

That for and in consideration of the sum of **Three Thousand Sixty-Seven Dollars and 20/100 Cents (\$3,067.20)**, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and do hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, the permanent right to lay, construct, operate, repair, reconstruct and remove sanitary sewer improvements and appurtenances thereto, which sanitary sewer improvements and appurtenances shall be of such dimension, character, construction and use determined by Grantee, along, through, under and across the following tract of land located in the confines of Lexington-Fayette County, Kentucky, and more particularly described as follows:

**Permanent Sanitary Sewer Easement**  
**1195 Mt. Rushmore Way**  
**Century Hills Sanitary Sewer Improvement Project**

Described on Exhibit A attached hereto and incorporated herein by reference.

**FURTHER**, for and in consideration of the foregoing sum, the receipt and sufficiency of which is hereby acknowledged, Grantors have **BARGAINED** and **SOLD** and do hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, the temporary right to excavate, grade, construct, alter, regrade and perform related work for

the purpose of sanitary sewer construction, repair, installation and relocation through and across the following tract of land located within the confines of Lexington-Fayette County, Kentucky, to-wit:

**Temporary Construction Easement**  
**1195 Mt. Rushmore Way**  
**Century Hills Sanitary Sewer Improvement Project**

All temporary construction easements, if any, are described on Exhibit B attached hereto and incorporated herein by reference.

**TO HAVE AND TO HOLD** the above-described easement together with all rights, privileges, appurtenances and improvements thereunto belonging unto Grantee, its successors and assigns forever, for the purposes and uses herein designated.

The above-described temporary construction easement will expire upon completion of the construction of the improvement project on the land adjacent to this easement, runs with the land for the duration of the improvement project on the adjacent land, and is binding upon the heirs and assigns of the Grantors.

Grantors do hereby covenant to and with said Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the easements conveyed herein, and that they will **WARRANT GENERALLY** said title.

Grantors shall have the full right to use the surface of the land lying over said permanent easement for any purpose desired, provided such use will not interfere with the Grantee's free use of the easement herein granted and provided further that no building or structure shall be erected upon, across, over or through said permanent easement without the prior written consent of the Grantee.

The obtaining of this easement was authorized by Resolution No. 389-2013 passed by the Lexington-Fayette Urban County Council on July 9, 2013. Pursuant to

KRS 382.135(2)(a), this public utility easement is exempt from the requirements related to certificate of consideration. This conveyance is exempt from real estate transfer tax pursuant to KRS 142.050.

All those tracts or parcels of land situated on the southwesterly side of Mt. Rushmore Way, southeasterly from its intersection with Pimlico Parkway, in Lexington, Fayette County, Kentucky, and more fully described and bounded as follows, to-wit:

**Permanent Sanitary Sewer Easement:**

Beginning at a point in the common line of Lot 33B and Lot 33A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 595), said point being approximately 47.1 feet northeasterly from the rear common corner of said lots as measured along said common line; thence along the common line of Lots 33B and 33A, N 46° 31' 07" E 20.14 feet; thence through Lot 33B, S 36° 40' 44" E 32.07 feet to a point in the common line of Lot 33B aforesaid and Lot 34, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet E, Slide 758); thence along said common line, S 47° 08' 56" W 20.12 feet; thence again through Lot 33B, parallel with and twenty feet southwesterly from the second call cited above, N 36° 40' 44" W 31.85 feet to the beginning and containing 639 square feet.

**Temporary Construction Easement - Tract 1:**

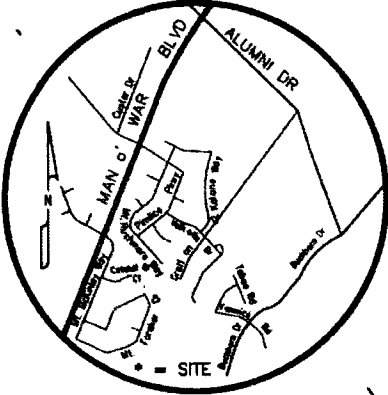
Beginning at the northeasterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 33B and Lot 33A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 595); thence along said common line, N 46° 31' 07" E 10.07 feet; thence through Lot 33B, parallel with and ten feet northeasterly from the northeasterly line of the above described permanent sanitary sewer easement, S 36° 40' 44" E 32.18 feet to a point in the common line of Lot 33B aforesaid and Lot 34, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet E, Slide 758); thence along said common line, S 47° 08' 56" W 10.06 feet; thence again through Lot 33B, along the northeasterly line of the above described permanent sanitary sewer easement, N 36° 40' 44" W 32.07 feet to the beginning and containing 321 square feet.

**Temporary Construction Easement - Tract 2:**

Beginning at the northwesterly corner of the above described permanent sanitary sewer easement, said point being in the common line of Lot 33B and Lot 33A, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet D, Slide 595); thence through Lot 33B, along the southwesterly line of the above described permanent sanitary sewer easement, S 36° 40' 44" E 31.85 feet to a point in the common line of Lot 33B aforesaid and Lot 34, Block D, Unit 2-B of Century Hills Subdivision (Plat Cabinet E, Slide 758); thence along said common line, S 47° 08' 56" W 10.06 feet; thence again through Lot 33B, parallel with and ten feet southwesterly from the southwesterly line of the above described permanent sanitary sewer easement, N 36° 40' 44" W 31.73 feet to a point in the common line of Lots 33B and 33A aforesaid; thence along said common line, N 46° 31' 07" E 10.07 feet to the beginning and containing 318 square feet.

Being a twenty-foot wide permanent sanitary sewer easement and ten-foot wide temporary construction easements on a portion of the same property conveyed to grantors by deed dated November 12, 1988, and of record in Deed Book 2016, Page 510; being designated as Lot 33B, Block D, Unit 2-B of Century Hills Subdivision as per the Amended Final Record Plat of record in Plat Cabinet D, Slide 595. VICINITY MAP

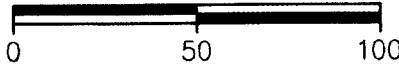

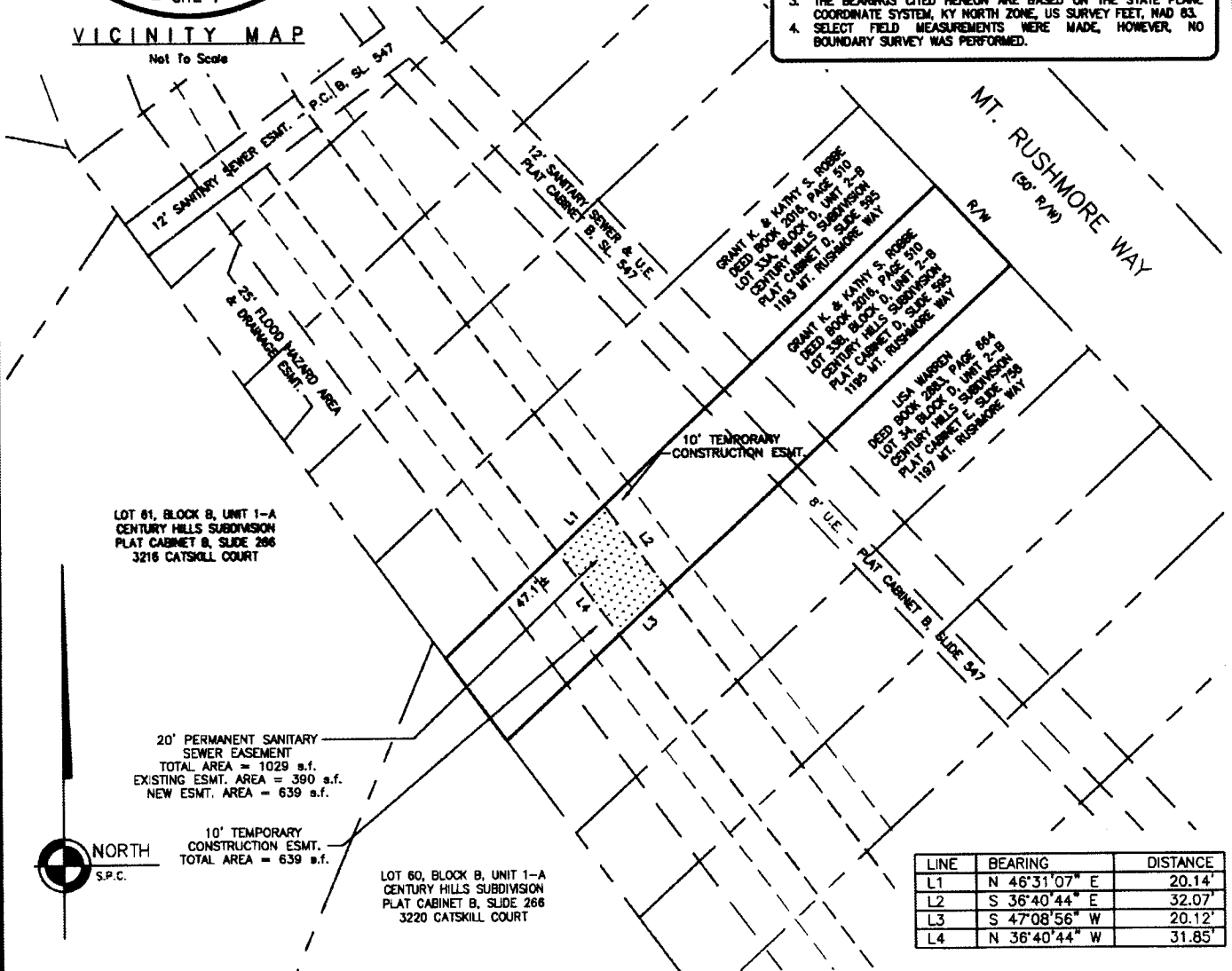

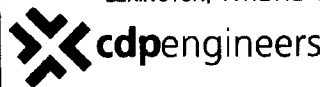
