That for and in consideration of the sum of NINE HUNDRED THIRTY-SIX DOLLARS AND 00/100 (\$936.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantors have BARGAINED and SOLD and do hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Thence North 51 degrees 50 minutes 23 seconds East, 40.12 feet to a point 50.77 feet left of Mt. Tabor Road station 15+75.34;

Thence South 39 degrees 59 minutes 57 seconds East, 19.91 feet to a point 30.86 feet left of Mt. Tabor Road station 15+75.35;

Thence South 49 degrees 27 minutes 34 seconds West, 40.10 feet to the point of beginning;

The above described parcel contains .019 acres (832 sq. ft.) of temporary easement; and,

Being a portion of the property conveyed to Yong Lee (f/k/a Yong Y. Williams) and Dae Lee, wife and husband, by deed dated August 1, 2005, of record in Deed Book 2578, Page 594, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project on this land and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the commencement of construction of the project and shall be binding until the completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have

good right to sell and convey the same as herein done, and that they will **WARRANT GENERALLY** said title.

The obtaining of this easement was authorized by Resolution 605-2015, passed by the Lexington-Fayette Urban County Council on October 8, 2015. Pursuant to KRS 382-135(2)(a), this public utility easement is exempt from real estate transfer tax pursuant to KRS 142.050.
