

Highlights

- United States Interagency Council on Homelessness Designation of "Effectively Ending Veteran Homelessness"
- Built a Coordinated Entry system
- Development innovative programming
 - 48 New Programs
- Coordinated a comprehensive and effective response to a once in a 100-year pandemic
- Increased Continuum of Care partners from 16 to over 75 diverse and in organizations
- In full compliance with Department of Housing and Urban Development
- Increase federal funding by 33%
 - 2014: 88% of ask funded
 - 2020: 102.5% of ask funded







Still A LOT of Work to be Done

- Hired consultant in December 2019
- Started gathering information in Jan-March 2020
 - Key Informant Interviews
 - Six Strategic Planning sessions
 - Secondary data analysis
 - Surveys from those experiencing homelessness
- **2021-2025**
 - Five-year Strategic Plan to Reduce and Effectively End Homelessness and Enhance Affordable Housing in Fayette County
 - 55 Recommendations/Action Steps

Goals/Objectives

Community Outreach and Engagement

- Create a Centralized Public Education Campaign (\$50,000 annually)
- Expand Access and Use of Public Data Interface (\$115,000 annually)
- Establish Onboarding Curriculum for Case Managers (unknown)

Preventing Homelessness

- Eviction Diversion and Mediation Program (\$1,500,000 first year)
- Expand Existing Reentry Program into Jails (\$65,000 annually)

Policy and Advocacy

Local Lawmaker Engagement (no additional cost)

Funding Sources

- Enhance Use of Lex End Homelessness Fund at Bluegrass Community Foundation (\$120,000 annually)
- Leverage Chamber of Commerce Support (no additional cost)

Expanding Permanent Supportive Housing

- Establish Homeless Preference for Housing Choice Vouchers (no additional cost)
- Establish Moving on Strategies with Housing Authority (no additional cost)
- Expand Permanent Supportive Housing Units (\$2 million annually chronically homeless base cost – estimates as high as \$8 million annually for full impact)
