Capitalized terms used in this Addendum but not defined herein will have the meanings set forth in the Master Agreement.

Amendments to the Springbrook Software Maintenance Addendum Mutually Executed on 2/21/14

Section 2.1 "Scope of Maintenance Services" shall be amended to include:

Standard support hours are from 8:00am-8:00pm Easter Standard Time, Monday through Friday and excluding holidays. Emergency 24x7 hotline is available for citizen facing portals experiencing outages.


Section 3.3 "Key Personnel Replacement" shall be deleted in it's entirety

Amendments to the Springbrook Software Order Form mutually executed 6/30/14

Client has elected to implement Cloud Services and not pursue a Managed Hosting environment. As a result \$59,800 shall be credited to the Client's account, and a fee of \$18,552 shall be applied. In the event that client elects in the future to utilize a Managed Hosting Service in lieu of Cloud Services the fee of \$59,800 shall apply.
