WHEREAS, by Resolution No. 93-2014 adopted by the Council of the Lexington-Fayette Urban County Government on the 6th day of March, 2014, the Council authorized and directed the Mayor to execute a quitclaim deed transferring a portion of the right-of-way located adjacent to the property located at 2169 Lakeside Drive;

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00), and for other good and valuable consideration, the receipt of all of which consideration is hereby acknowledged by Grantor, said Grantor does hereby REMISE, RELEASE and forever QUITCLAIM unto the Grantee, its successors and assigns forever, all of its right, title and interest in and to the portion of the right-of-way authorized to be transferred by the above-referenced Resolution and being further described as follows:

2169 Lakeside Portion of right of way to be Quit Claimed

Beginning at a crimped iron pin at the common corner of lots 11 and 12, of Lakeview Estates Unit 3 Section 2 Part 1, recorded in Plat Cabinet B Slide 45, thence, along the rear line of lot 12 S 26°12'04" E a distance of 160.96' to a crimp iron pin found at the common corner of lots 12 and 13.

Main Street Lexington, Ky. 40507 Thence, leaving the line of Lakeview Estates S 46°21'40" W a distance of 51.56', to an iron pin with plastic cap stamped "2020", set three feet from and existing asphalt road. Thence, along a line offset three feet from said asphalt road for five calls: N 50°03'59" W a distance of 10.85', to a point. N 41°28'25" W a distance of 31.55' to a point. N 32°15'00" W a distance of 39.21', to a point. N 23°00'46" W a distance of 44.87', to a point. N 21°24'11" W a distance of 52.97', to an iron pin set with plastic cap stamped "2020". Thence, leaving said line N 64°18'07" E a distance of 59.10' to the point of beginning. Having an area of 10503.28 square feet, 0.241 acres.

TO HAVE AND TO HOLD the same unto the Grantees, their successors or assigns, forever, subject to all easements and encumbrances of record and to any and all rights of others recognized and/or permitted by the Grantor for the presence of utilities in or upon the property, and in respect to such utility rights, where no easement exists. This instrument is exempt from the requirements for a Consideration Certificate by KRS 382.135(2)(c).

IT IS AGREED AND UNDERSTOOD that no structure, i.e. fence or otherwise, be constructed within 15 feet from the edge of pavement. That the erection and/or maintenance of off-premise advertising devices, including but not necessarily limited to billboards, upon the above-described property is prohibited.
