BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT.

Section 6 – That the incumbent to the position of Community Reentry Advocate, Tara Estes, be and hereby is transferred from the Office of the Mayor, to the Office of the Chief Development Officer, at her respective current pay grade and rate of pay, to expire December 31, 2026.
