SCOPE OF WORK AND BUDGET SUMMARY

Town Branch Trail Phase V

Construct 1.5 miles of shared use path connecting between Town Branch Trail Phase III, Town Branch Trail Phase VI, and Townley Center.

The supplemental agreement alters the scope of Phase V to include Phase IV utilities and future construction under the phase V project and obligates \$810,000 for utilities for the combined project. All remaining funds awarded to the Phase IV project will be available to the new Phase V combined project. The original Design and ROW activities will remain under the original Phase IV project.

All federally-funded CMAQ projects are set up in phases (design, ROW, utilities, construction). No work can begin on any phase of a project until the KYTC Office of Local Program provides a written notice to proceed for that phase. Funding for this project will be programmed with FHWA as each phase is approved. Effective December 26, 2014, FHWA requires a project end date for each federal project phase programmed. As each phase of the project is programmed with FHWA a supplemental agreement will be sent to the project sponsor to add the funding and adjust the project end date. Any

expenditures incurred by the project sponsor after the end date will not be eligible for reimbursement. If the project sponsor requires an extension, they must notify the Office of Local Programs thirty (30) days before the project end date.
