### The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states: The Contractor will not discriminate against any employee or applicant for employment because of physical or mental disability.
- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment
  Opportunity, states: The Secretary of Labor may investigate the employment practices of any Government contractor
  or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have
  been violated.

- 15. Authority to do Business: Each bidder must be authorized to do business under the laws of the Commonwealth of Kentucky and must be in good standing and have full legal capacity to provide the goods or services specified in the bid proposal. Each bidder must have all necessary right and lawful authority to submit the bid response and enter into the bid contract for the full term hereof including any necessary corporate or other action authorizing the bidder to submit the bid response and enter into this bid contract. If requested, the bidder will provide LFUCG with a copy of a corporate resolution authorizing this action and/or a letter from an attorney confirming that the proposer is authorized to do business in the Commonwealth of Kentucky. All bid responses must be signed by a duly authorized officer, agent or employee of the bidder.
- Governing Law: This bid request and bid contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this matter, the bidder agrees that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division and that the bidder expressly consents to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to these matters or any rights or obligations arising thereunder.
- 17. Ability to Meet Obligations: Bidder affirmatively states that there are no actions, suits or proceedings of any kind pending against bidder or, to the knowledge of the bidder, threatened against the bidder before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of bidder to perform its obligations under this bid response or bid contract, or which question the legality, validity or enforceability hereof or thereof.

1.1 This specification describes the minimum requirements to establish a price contract for automobile and light duty truck repairs to be provided as needed when LFUCG in-house resources are unavailable.

## 2. REQUIREMENTS

- 2.1 Typical repair activity will include, but not be limited to, diagnosis and repair of engines, transmissions, axles, steering, suspension, brakes, HVAC and electrical systems.
- 2.2 In the interest of obtaining the best possible service and repair outcomes, bidders shall be a certified repair facility, with a business front in a permanent location with proper tools and equipment.
- 2.3 LFUCG Fleet Service will be responsible for delivery of vehicles to and from contractor's facility.
- 2.4 A written estimate shall be supplied within 48 hours of receipt of vehicle before work is authorized to proceed.
- 2.5 Unless otherwise authorized all parts used for repairs under the terms of this price contract shall be produced or approved by the original equipment manufacturer.
- 2.6 LFUCG owned vehicles include but not limited to Ford, GM, Dodge, Honda, and Toyota including both cars and trucks.
- 2.7 LFUCG reserves the right to supply own parts on special occasions as a cost saving measure.

## 3. METHOD of AWARD

- 3.1 A price contract will be issued to the responsive and responsible bidder or bidders who has the demonstrated ability to provide the required services at the lowest rate.
