
BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute an Amendment to Agreement, which is attached hereto and incorporated herein by reference, with the Kentucky Transportation Cabinet, for extension of the Illuminated Street Sign Project, extending the performance period through June 30, 2014, at no cost to the Urban County Government.

Section 2 - That this Resolution shall become effective on the date of its passage.



On May 27, 2010 (Ordinance No. 90-2010), Council approved acceptance of federal funds from the Kentucky Transportation Cabinet in the amount of \$365,000 from the Congestion Management/Air Quality Program for the Illuminated Street Sign Project. The project expires June 21, 2013. The Kentucky Transportation Cabinet has offered the LFUCG an amendment to the agreement providing for an extended performance period through June 30, 2014. No other changes are made to the original agreement.

Approximately 100 of the internally lighted signs are being installed to assist visitors and other motorists as they travel in and around the community.

The federal amount for the project is \$365,000. Required matching funds of 20% will be met through toll credits. Total project amount is \$365,000. Federal funds are from the federal Congestion Management/Air Quality Program (CMAQ) allocation.

Council authorization to execute Amendment to Agreement is hereby requested.
