

A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBER OF 1150-1156 INDUSTRY ROAD TO 1154 INDUSTRY ROAD AND CHANGING THE STREET NAMES AND PROPERTY ADDRESS NUMBERS OF 981 W. HIGH STREET TO 850 DERODE STREET, 890 RUSSELL CAVE ROAD TO 199 W. LOUDON AVENUE, 385 S. MILL STREET TO 305 W. MAXWELL STREET, 933-937 W. HIGH STREET TO 950 VALLEY ROAD, ALL EFFECTIVE THIRTY (30) DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following property be and hereby are changed as follows:

(a) Industry Road

<u>Current</u>	<u>New</u>
1150-1156 Industry Road	1154 Industry Road

Section 2 – That the street names and property address numbers of the following properties be and hereby are changed as follows:

(a) W. High Street: That the name of W. High Street located at 981 is changed to DeRoode Street and the name of W. High Street located at 933-937 is changed to Valley Road and the following number changes are made:

<u>Current</u>	<u>New</u>
981 W. High Street	850 DeRoode Street
933-937 W. High Street	950 Valley Road

(b) Russell Cave Road: That the name of Russell Cave Road located at 890 is changed to W. Loudon Avenue and the following number changes are made:

Current  
890 Russell Cave Road

New  
199 W. Loudon Avenue

- (c) S. Mill Street: That the name of S. Mill Street located at 385 is changed to W. Maxwell Street and the following number changes are made:

Current  
385 S. Mill Street

New  
305 W. Maxwell Street

Section 3 - That this Resolution shall be effective thirty (30) days from passage.
