Mr. J. Brown expressed appreciation for Mr. McCurn's recognition of Pastor Gaines and Consolidated Baptist Church and lauded the Church for their work throughout the COVID-19 pandemic. He also commended the University of Kentucky for hosting COVID-19 testing and vaccination clinics, and reminding those in his district of the vaccination clinic to be held Saturday, April 10 at the Charles Young Center. He also announced that on Saturday, April 10, at 2 p.m., America in Bloom in partnership with East End Neighborhood Association would be hosting a Daffodil Drift Party at Charles Young Park.

Mr. J.
