

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS WITH RABBIT RUN HOMEOWNERS ASSOCIATION (\$1,000.00), PALOMAR HILLS COMMUNITY ASSOCIATION (\$600.00), THE VILLAGE OF RABBIT RUN CONDO ASSOCIATION (\$500.00), AYLESFORD PLACE NEIGHBORHOOD ASSOCIATION (\$500.00), MENTELLE NEIGHBORHOOD ASSOCIATION (\$1,000.00), GROWING TOGETHER PRESCHOOL (\$1,050.00), MARY TODD LINCOLN HOUSE (\$550.00), CAPTAIN UNDERWOOD YOUNG MARINES (\$800.00), LEXARTS ON BEHALF OF ART CONNECTS (\$1,000.00), HISTORIC WOODWARD HEIGHTS NEIGHBORHOOD ASSOCIATION (\$500.00), BELL COURT NEIGHBORHOOD ASSOCIATION (\$900.00), AND EAST END COMMUNITY DEVELOPMENT CORPORATION (\$500.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUMS STATED.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:


Section 3 - That this Resolution shall become effective on the date of its passage.
