Motion by F. Brown to refer ordinance number 6 (An Ordinance amending Articles 1, 6-4(a), 6-8(b), 6-8(d)(1) and (2), and 6-8(f) of the Land Subdivision Regulations to revise standards for street patterns and continuity.) to the Planning & Public Safety Committee. Seconded by McCurn. Motion passed without dissent.

Motion by LeGris to add a presentation recognizing the UK Rifle team to the May 6, 2021 Council meeting docket, immediately before public comment. Seconded by McCurn. Motion passed without dissent.

Motion by Lamb to place on the Council Meeting docket for Thursday, May 6, 2021, a Resolution authorizing the Mayor to accept a grant from the U.S. Department of Housing and Urban Development in the amount of \$1,441,081.00 in federal funds, for continuation of the Housing Opportunities for Persons with AIDS (HOPWA) Grant Program, the acceptance of which does not obligate the Urban County Government to the expenditure of funds, and authorizing the Mayor to execute a subrecipient agreement with AVOL Kentucky, Inc., for continuation of the project, at a cost not to exceed \$1,397,849.00. Seconded by Kay. Motion passed without dissent.

Motion by Kay to place on the May 6, 2021 Council meeting docket, a resolution amending resolution no. 269-2020, which placed \$6,400,000 of Federal Reimbursement Funds received from the Department for Local Government into the Contingency Designation Fund (ordinance no. 50-2026), to reduce the amount to \$1,800,000 with the difference of \$4,600,000 being placed into the General Fund (Budget Stabilization Reserve). Seconded by F. Brown. Motion passed 13-2. Kay, Ellinger, J. Brown, McCurn, LeGris, Sheehan, Kloiber, Worley, F. Brown, Baxter, Bledsoe, Reynolds and Plomin voted yes. Moloney and Lamb voted no.

Motion by Kay to amend and remove "instructing and directing" and replace with "urging"; to remove the "update and implement as soon as practicable" from heading; remove section from page 1 starting with "the Commission further found..."; add language in last whereas "any and all contributing factors to these issues" and remove "housing scarcity"; update final paragraph in section 1 to match the proposed amendments to the preamble. Seconded by Lamb. Motion passed without dissent.

Motion by Kloiber to amend the amendment and restore the language in the "whereas" paragraphs. Seconded by F. Brown. Motion passed without dissent.
