

ORDINANCE NO. 024 - 2021

AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO REFLECT CURRENT REQUIREMENTS FOR FUNDS IN THE AMOUNT OF \$6,600.00 TO PROVIDE FUNDS FOR COUNCIL PROJECTS IN THE DIVISION OF PARKS AND RECREATION FOR THE INSTALLATION OF A WATER SOURCE IN KIRKLEVINGTON PARK AND STARTUP OF THE FAIRLINGTON COMMUNITY GARDEN PROJECT AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO. 0042.
