## FIRST AMENDMENT TO BENEVATE INC SAAS SERVICES AGREEMENT BETWEEN BENEVATE INC AND LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT

THIS FIRST AMENDMENT TO SAAS SERVICES AGREEMENT (this "First Amendment") is made as of December \_\_\_\_\_\_\_, 2019, between Benevate, Inc ("Company") and Lexington-Fayette Urban County Government ("Customer").

## **RECITALS**

- B. The Customer has determined that it is necessary to amend the Agreement with the Company to (i) add additional services to the Scope of Work of the Agreement (the "Additional Services") and (ii) increase the compensation of the Company for the Additional Services.
- C. The Company and the Customer desires to enter into this First Amendment to (i) include the Additional Services and (ii) increase the compensation of the Company for the Additional Services.

## **AGREEMENT**

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by reference, the following mutual covenants and conditions and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company and the Customer hereby agree to amend the Agreement as follows:

- 1. <u>Scope of Work</u>. The Company shall provide the Additional Services as set forth in Exhibit A, attached hereto and incorporated herein by reference.
- Compensation. The Customer shall pay Company one-time implementation fees and recurring per user fees as set forth in Exhibit A, attached hereto and incorporated herein by reference.
- 3. <u>Effect of Amendment.</u> In all other respects, the Agreement is affirmed and ratified and, except as expressly modified herein, all terms and conditions of the Agreement shall remain in full force and effect.
