BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute agreements related to Neighborhood Development Funds, which are attached hereto and incorporated herein by reference, with the following entities: The Kentucky Center for Grieving Children and Families Inc.; Southland Jamboree Association Inc.; Lafayette High School Track and Field Booster Club; Grin Grant Inc.; Downtown Lexington Partnership; Greater Gardenside Association, LLC; Pine Meadows - Cardinal Hill - Mason Headley Neighborhood Association, Inc.; Meadowthorpe Neighborhood Association, Inc.; Arts Connect, Inc.; Casa de la Cultura Hispana de Lexington Corporation; Hill-N-Dale Neighborhood Association, Inc.; Lansdowne-Merrick Neighborhood Association, Corporation; Ashland Neighborhood Association, Inc.; Girls on the Run Lexington Corporation; and Ashland, The Henry Clay Estate, for the Office of the Urban County Council.
