

**SECOND AMENDMENT TO
CONTRACT FOR SERVICES**

THIS SECOND AMENDMENT TO CONTRACT FOR SERVICES, made and entered into this ____ day of _____, 2026, (the “Effective Date”) by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT (“LFUCG”)**, on behalf of its Division of Environmental Services, and the **Kentucky Association for Environmental Education (“KAEE”)** of Elizabethtown, Kentucky, (collectively known as the “Parties”).

RECITALS

WHEREAS, the Parties entered into a Contract approved pursuant to R-395-2024 (the “Contract”) to provide environmental education services;

WHEREAS, the Parties seek to expand curriculum and programming as it pertains to waste contamination reduction and recycling right; Complete Streets and Vision Zero; expanded Out of School Time programming; and Workforce Development for the Department of Environmental Quality and Public Works and the Division of Planning;

WHEREAS, the Parties desire to amend the Contract to include additional services and compensation as outlined herein; and

WHEREAS, the Parties hereby agree to amend the above-referenced term and total payment amount in accordance with the terms and conditions of the Amendment.

STATEMENT OF AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree to amend the Contract as follows:

- 1. INCORPORATION OF RECITALS.** The above recitals and referenced exhibits are incorporated herein as part of this Amendment.
- 2. SCOPE OF SERVICES.** In addition to the services required under the original Contract and Amendment 1, KAEE shall provide the additional services described in Exhibit 1, attached hereto and incorporated herein by reference. These additional services include:
 - a. Expanded Environmental Education Services.** KAEE will support and promote the city’s waste contamination reduction and recycling right efforts; Complete Streets and Vision Zero; Out of School Time programming; and Workforce Development programming for the Department of Environmental Quality and Public Works and the Division of Planning. Funds will cover curriculum development, educator time, transportation, supplies, and field experience expenses.

3. **COMPENSATION.** For the additional services described in Exhibit 1, LFUCG agrees to pay KAEE an additional amount of **One Hundred Seventy-One Thousand Dollars (\$171,000.00)**.
4. **EFFECT.** All other provisions of the Contract, which are not inconsistent with the provisions of this Amendment shall remain in full force and effect.

Exhibit 1

Amendment to the Environmental Education Services Scope of Work

Agreement with Kentucky Association for Environmental Education - Resolution R-395-2024

In addition to the services required under the original Contract and the Contract as subsequently amended, KAEE shall provide these additional services.

Additional General, Sanitary Sewer, Water Quality, and Landfill Funds

The following activities cut across topic areas; therefore, time will be charged to the appropriate fund as the work is completed with some time being split proportionally across multiple funds.

- A pilot Workforce Development effort, YLEX Works, that includes:
 - A free summer camp for middle school students to explore careers related to the Department of Environmental Quality and Public Works and the Division of Planning
 - A program for Fayette County high school students that provides them with career readiness training, shadowship experiences, and internship opportunities
- Expanded out-of-school time (OST) programming for after school and academic breaks

New Activities Specific to General Funds

The development of curriculum-aligned, K-12 units of study related to Planning, specifically Complete Streets and Vision Zero, will be funded fully from the General Fund.

Use of Landfill Funds

Expanded efforts aimed at reducing recycling contamination and the anticipated rollout of an updated acceptable items list will be funded using these Landfill Funds, along with Urban Services Waste Management Funds included in the base contract.
