

TEMPORARY CONSTRUCTION EASEMENT

This **TEMPORARY CONSTRUCTION EASEMENT** is made and entered into this 10 day of JUNE 2015, by and between **THOMAS D. ADKINS AND REBECCA H. ADKINS**, husband and wife, 3741 Polo Club Boulevard, Lexington, Fayette County, Kentucky 40509, which is the in-care of tax mailing address for the current year ("Grantors"), and **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

WITNESSETH:

That for and in consideration of the sum of **FIVE HUNDRED SEVENTY-FIVE DOLLARS AND NO/100 (\$575.00)**, and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, said Grantors have **BARGAINED** and **SOLD** and do hereby **GIVE, GRANT, and CONVEY** unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows based upon Lexington-Fayette Urban County Control Survey Monuments:

Temporary Construction Easement
(a portion of 3741 Polo Club Boulevard)

Polo Club Boulevard Road Improvement Project
(Deerhaven Lane to Todds Road)

Being a tract of land lying in Fayette County along Polo Club Boulevard approximately 1260' north of the intersection of Polo Club Boulevard and Todds Road (KY 1927), and more particularly described as follows:

Beginning at a point in the existing right-of-way line of Polo Club Boulevard 70.00 feet right of Polo Club Boulevard station 510+45.00; thence with the existing right-of-way, N 45°46'09" W, a distance of 24.88' to a point 70.00 feet right of Polo Club Boulevard station 510+69.88; thence with the north property line, N 43°56'12" E, a distance of 20.00' to a point 90.00 feet right of Polo Club Boulevard station 510+69.98; thence with the proposed easement line, S 23°57'19" E, a distance of 26.91' to a point 80.00 feet right of Polo Club Boulevard station 510+45.00; thence S 44°13'51" W, a distance of 10.00' to the POINT OF BEGINNING. The above described parcel contains 373.74 square feet (0.009 acres); and,

Being a portion of the same property conveyed to Thomas D. Adkins and Rebecca H. Adkins, husband and wife by deed dated June 1, 2007, of record in Deed Book 2731, Page 689, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement unto said Grantee, its successors and assigns, for the purposes and uses herein designated.



Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the same as herein done, and that they will **WARRANT GENNERALLY** said title.


The obtaining this easement was authorized by Resolution 16-2015, passed by the Lexington-Fayette Urban County Council on January 29, 2015. Pursuant to KRS 382-135(2)(a), this public utility easement is exempt from real estate transfer tax pursuant to KRS 142.050.



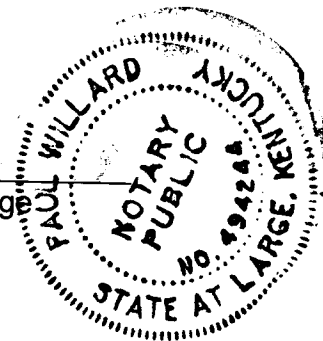


