**SUBJECT: Amendment to Agreement with KYTC for Town Branch Trail Commons –
Midland Section**

Request: Request Council authorization to execute Amendment to Agreement with Kentucky Transportation Cabinet to extend period of performance for the Town Branch Trail Commons – Midland Section through June 30, 2019

Purpose of Request: On June 16, 2016 (Resolution No. 356-2016), Council authorized acceptance of federal funds in the amount of \$320,000 for the design phase of a bike trail between the Legacy Trail trailhead at Isaac Murphy Memorial Art Garden and Vine Street at the intersection with Quality Street. The dedicated 12' off-road multi-use trail along the west side of Midland Avenue is one component of the 2.5 mile trail that will eventually connect Town Branch Trail to Legacy Trail through downtown, providing a safe route for cyclists and pedestrians along the corridor.

The Kentucky Transportation Cabinet is extending the Period of Performance to June 30, 2019.

Cost in this Budget year and future budget years: This action will not result in an increase in project costs.

Are the funds budgeted? All federal funds and required match are budgeted.
