Administrative Synopsis - New Business Items

Authorization to execute a contract between ESO Solutions and the Lexington Division of Fire and Emergency Services for patient care reporting software. This contract is needed in order to update the patient care reporting software and maintain compliance with new state laws. No budgetary impact. (L7-16) (Hoskin/Bastin)

Authorization to abolish one (1) unclassified position of Eligibility 513E) and Counselor (Grade create one (1) unclassified position Life Skills **Program** Instructor (Grade of 512N): reclassifying the incumbent within the Division Services, effective upon passage of Council. Upon the request of the division, the Division of Human Resources conducted a reclassification study on the requested position of Eligibility Counselor held by John Walker within the Division of Youth Services. As a result, a recommendation for the reclassification is described in this action. There will be no change in his salary and this will not have a 12-month future impact cost. - Authorization to request a resolution authorizing the acceptance of deeds of permanent right of way and acquisition of easement from the owners of record on properties at 553 and 549 Cane Run Road for the Cane Run Road Stormwater Improvement Project. The purpose of the deed for permanent easement is to allow for construction of stormwater improvements on Cane Run Rd. There is no cost in FY16 or future years with this request. - d 1632-16 Authorization to execute an amendment to the Squire Oak Neighborhood Association Neighborhood Action Match Agreement to modify the scope of work to include replanting of trees. No budgetary impact. (L1632-16) (Gooding/Hamilton)
- 1634-16 Authorization with to execute amendment to agreement Lexington-Fayette, Community Action Council for Bourbon, and Nicholas Inc for use HOME Counties. of Investment Partnership Funds for support of a Tenant Based Rental Assistance Project. This amendment to Resolution 175-13 provides for an extension of the performance period

through December 31, 2016. No additional funds are needed. (L1634-16)(Gooding/Hamilton)
