Bids to establish a price contract for Mowing City Areas, Medians, Nuisance & Downtown Parks for the Division of Parks and Recreation were received in the Division of Central Purchasing on February 17, 2012.

Economic Engine notified two hundred fifty-one (251) vendors with eighty-one (81) vendors viewing the document. Twenty-seven (27) bids were received.

- Wright's Home Improvement & Mowing LLC submitted the lowest bid for Right of Way Pkg 1 but withdrew their bid. The second lowest bid was submitted by SCINA Lawncare Services LLC but withdrew their bid for this package. The third lowest bid was submitted by Somethin Bloomin but they withdrew their bid for this package. The fourth lowest bid was submitted by McGee Springs Inc.
- Wright's Home Improvement & Mowing LLC submitted the lowest bid for Right of Way Pkg 2 but withdrew their bid. The second lowest bid was submitted by Somethin Bloomin but they withdrew their bid for this package. Landscape Supply and Design submitted the third lowest bid.
- SCINA Lawncare Services LLC submitted the lowest bid for Right of Way Pkg 3.
- J&S Turf Mowing Inc submitted the lowest bid for Right of Way Pkg 4.
- Lexington Turf Maintenance submitted the lowest bid for Right of Way Pkg 5 but withdrew their bid due to error on their submission. The second lowest bid was submitted by J&S Turf Mowing Inc.
- J&S Turf Mowing submitted the lowest bid for Right of Way Pkg 6.
- ZKB Construction Service LLC submitted the lowest bid for Parks Bid Pkg 1.
- Lexington Turf Maintenance submitted the lowest bid for Parks Bid Pkg 2.
- Gault's Lawncare Inc submitted the lowest bid for Parks Bid Pkg 3.
- Somethin Bloomin submitted the lowest bid for Parks Bid Pkg 4.
- Somethin Bloomin submitted the lowest bid for Parks Bid Pkg 5.
- Gault's Lawncare Inc submitted the lowest bid for Parks Bid Pkg 6.

- Wright's Home Improvement & Mowing LLC submitted the lowest bid for Non-Water Quality Greenway Pkg but withdrew their bid. The second lowest bid was submitted by SCINA Lawncare Services LLC.
- Lexington Turf Maintenance submitted the lowest bid for the Legacy Trail but withdrew their bid. The second lowest bid was submitted by SCINA Lawncare Services LLC.
- ZKB Construction Service LLC submitted the lowest bid for Water Quality Pkgs, North, South, East, and West but withdrew their bid. McGee Springs Inc submitted the second lowest bid for Water Quality Pkgs North, East and West. J&S Turf Mowing Inc submitted the second lowest bid for Water Quality Pkg South but withdrew their bid. McGee Springs Inc submitted the third lowest bid for Water Quality Pkg South.
- BJ Mowing, Central Kentucky Turf Inc, Gainesway Services, Gault's Lawn Care Inc, Happy's General Contracting Maintenance, J&S Turf Mowing Inc, Landscape Supply and Design, LexLawn LLC, Mow Edge Blow, SCINA Lawncare Services LLC, Wright's Home Improvement & Mowing LLC, and ZKB Construction Service LLC submitted multi-unit pricing for Nuisance Mowing. Wright's Home Improvement & Mowing LLC withdrew their bid.

These bids meet bid specifications and are within budgetary constraints; therefore, I recommend the following bids be accepted:

- 5. ZKB Construction Service LLC, Parks Bid Pkg 1 and Nuisance Mowing.
- 6. Lexington Turf Maintenance, Parks Bid Pkg 2.
- 7. Gault's Lawncare Inc, Parks Bid Pkg 3, Parks Bid Pkg 6, and Nuisance Mowing.
