I am pleased to inform you that your organization has been selected to participate in National PAL’s FY 2024-2026 National Youth Mentoring Program with the award name referenced above. This program is funded through the U.S. Department of Justice, Office of Justice Programs, Office of Juvenile Justice and Delinquency Prevention (“OJJDP”) [Award number 15PJDP- 24-GG-016664-MENT], Assistance Listings Number Assistance (formerly CFDA) 16.726. The National PAL (“NPAL”) National Youth Mentoring Initiative will implement youth mentoring programs that strengthen and expand mentoring services to at-risk/high-risk youth populations, through PAL Member Chapters. Youth served under this program include those who a) live in communities with high community risk factors including poverty, unemployment, violent crime, and drug/gang involvement; b) attend schools that have a high percentage of students eligible for free and reduced-price meals and have high rates of absenteeism; c) are American Indian or Alaska Native; d) have one or more parents in the military; and/or e) live in rural communities. Mentors and mentees will participate in positive mentoring activities through PAL Member Chapters, providing greater opportunities for individual/group mentoring and academic achievement. The performance measurements for this initiative will include increasing the participating youth’s attitude toward/viewpoint of law enforcement, understanding of the dangers of drug and gang involvement, and increasing their perception of social supports.

Your organization will receive a subaward to serve **youth in the amount of** _____ to be used for direct operating expenses associated with the implementation of the National PAL Youth Mentoring program in partnership with National PAL. **All funds must be proportionately and appropriately expended or obligated between January 1, 2026, and December 31, 2026, and no funding under this grant shall be used for Research and Development. If sub awardees are not on track to meet these targets, they are required to submit a corrective action plan outlining how expenses will be incurred over future quarters to reach the appropriate targets prior to the end of the quarter. If sub awardees do not meet the quarterly percentage spenddown as listed above, NPAL reserves the right to reduce award amounts or rescind grant funding.

Disbursement and Use of Funds

Payment on this subaward will be authorized upon (1) submission, review and approval of this Subaward Agreement and appropriate supporting documentation, and (2) the organization's continued compliance and appropriate progress regarding the requirements of this award. The total subaward amount will be honored based on such compliance and appropriate progress. Actual payments will be made on a reimbursement basis upon submission, review, and approval of reports and appropriate documentation regarding expenditure of funds.

Funds may be used only for direct operating costs associated with stated project activities. All funds must be appropriately expended or obligated between January 1, 2026, and December 31, 2026, and these expenditures must be fully reported by January 31, 2027. Your organization will relinquish all rights and claims to award funds not appropriately expended or obligated by the spenddown targets outlined above and fully reported and documented by January 31, 2027.

The purchase of meals is not an allowable cost under the FY24 grant. Gratuity is also not reimbursable. You may only be reimbursed for up to \$100 per youth for the cost of snacks in connection with activities under this grant for the entirety of the grant cycle.

When planning field trips and other events, keep in mind that you may only be reimbursed for up to \$50 per youth.

Once the Executive Director has signed the document, it will automatically forward to the secondary signer for execution. The recipient's budget (and budget narrative) is pending clearance by OJP.

Prior to budget clearance (and unless there is a more restrictive condition on this award, in which case the terms of that more restrictive condition apply): The recipient may not drawdown more than 10% of the award. Pre-clearance obligations, expenditures, and drawdowns may be disallowed if not in compliance with program requirements.

The recipient should be judicious in using award funds prior to budget clearance. Generally, OJP expects that recipients (depending on the specific project scope) may need to advertise for award-funded positions, pay personnel and fringe benefits for positions budgeted under the award, plan for project activities, attend training and pay training-related travel needed to begin the project, and engage in other limited activities conducted by recipient staff (i.e., generally not requiring a subaward or procurement contract under an award).

OJP will issue an Award Condition Modification upon budget clearance.

The recipient may not obligate, expend, or draw down any award funds for indirect costs, unless and until either -- (1) the recipient submits to OJP a current, federally-approved indirect cost rate agreement, or (2) the recipient determines that it is

eligible under the Part 200 Uniform Requirements to use the "de minimis" indirect cost rate described in 2 C.F.R. 200.414(f), and advises OJP in writing of both its eligibility and its election.

The financial review of the budget for this award is pending. If the OJP Office of the Chief Financial Officer (OCFO) determines as part of its financial review that the recipient already has submitted the documentation concerning indirect costs described above, this condition will be released through a Grant Award Condition Modification (ACM) upon completion of the OCFO final budget review.

If the OJP OCFO instead determines as part of its financial review that the recipient has not yet submitted the required documentation concerning indirect costs, this condition will not be released until OJP (including its OCFO) receives and reviews a satisfactory submission.
