## **TEMPORARY CONSTRUCTION EASEMENT**

This TEMPORARY CONSTRUCTION EASEMENT is made and entered into this the 28 day of March, 2017, by and between CALVARY FREE METHODIST CHURCH CORPORATION, a Kentucky non-profit corporation, 2924 Clays Mill Road, Lexington, Kentucky 40503, which is the in-care of tax mailing address for the current year ("Grantor"), and LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

## WITNESSETH:

That for and in consideration of the sum of THREE THOUSAND TWO HUNDRED TWENTY-FIVE DOLLARS AND 00/100 (\$3,225.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantor has BARGAINED and SOLD and does hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

Temporary Construction Easement (a portion of 2924 Clays Mill Road)

Clays Mill Road Improvement Project, Section 1 (Harrodsburg Road to New Circle Road) Parcel No. 5

Being a tract of land lying in Fayette County on the east side of Clays Mill Road, point of beginning being approximately

122 feet south of the intersection of Galata Drive and Clays Mill Road, and more particularly described as follows:

Beginning at a point 41.93 feet right of Clays Mill Road at Station 119+86.54; thence North 23 Degrees 36 Minutes 36 Seconds East a distance of 178.29 feet to a point 42.00 feet right of Clays Mill Road at Station 121+64.83; thence South 66 Degrees 23 Minutes 24 Seconds East a distance of 15.42 feet to a point 57.42 feet right of Clays Mill Road at Station 121+64.83; thence South 23 Degrees 36 Minutes 36 Seconds West a distance of 74.86 feet to a point 57.39 feet right of Clays Mill Road at Station 120+89.96; thence South 27 Degrees 06 Minutes 24 Seconds West a distance of 103.62 feet to a point 51.03 feet right of Clays Mill Road at Station 119+86.53; thence North 66 Degrees 23 Minutes 24 Seconds West a distance of 9.10 feet to a point 41.93 feet right of Clays Mill Road at Station 119+86.54 and the POINT OF BEGINNING.

The above described parcel contains 0.056 acres (2,422 sq. ft.) of temporary construction easement;

Being a portion of the property conveyed to Calvary Free Methodist Church Corporation, a Kentucky non-profit corporation, by deed dated May 15, 1986 of record in Deed Book 1403, Page 423 in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantor. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon completion of the project.

Grantor does hereby release and relinquish unto the Grantee, its successors and

assigns forever, all of their right, title, and interest in and to the property to the extent of

the interest conveyed herein, including all exemptions allowed by law, and does hereby

covenant to and with the Grantee, its successors and assigns forever, that they are

lawfully seized in fee simple of said property and have good right to sell and convey the

same as herein done, and that they will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed

by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS

382.135(2)(c), this temporary construction easement, which pertains to a public right-of-

way, need not contain a statement of consideration.
