

AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) UNCLASSIFIED CIVIL SERVICE POSITION OF EXECUTIVE ASSISTANT TO MAYOR, GRADE 530E AND CREATING ONE (1) UNCLASSIFIED CIVIL SERVICE POSITION OF CHIEF OF STAFF, GRADE 537E, IN THE OFFICE OF THE MAYOR, EFFECTIVE UPON PASSAGE OF COUNCIL; AND REALLOCATING THE INCUMBENT, IN THE OFFICE OF THE MAYOR, APPROPRIATING FUNDS PURSUANT TO SCHEDULE NO. 0065.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That subsection line number 030.018 in the unclassified civil service authorized strength be and hereby is deleted.

Section 2 – That the following subsection line number in the unclassified civil service authorized strength be and hereby is created to read as follows:

030.015 1 231 537E Chief of Staff

Section 3 – That the incumbent, Jamie Emmons, be and hereby is reallocated from Grade 530E to Grade 537E, at \$4,538.46 biweekly.

Section 4 – That certain of the Budgets of the Lexington-Fayette Urban County Government are amended and funds are appropriated pursuant to Budget Schedule No. 0065, which is attached hereto and incorporated herein by reference.

Section 5 – That this Ordinance shall become effective upon date of passage.
