A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AGREEMENTS WITH EAST FAMILY REUNION COALITION (\$500.00), THE SOUTHLAND ASSOCIATION (\$2,000.00), SQUIRES ELEMENTARY PTA, INC. (\$900.00), CROSSROADS CHRISTIAN CHURCH (\$1,050.00), ACT MINISTRIES, INC. (\$250.00), NERD SQUAD, INC. (\$500.00), GAINESWAY NEIGHBORHOOD ASSOCIATION (\$1,000.00), LEXINGTON OAKS NEIGHBORHOOD ASSOCIATION, INC. (\$400.00), LAFAYETTE HIGH SCHOOL WOMEN'S BASKETBALL, INC.
