

PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the 27 day of ^{August} ~~MONTH~~ 2021, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and **KIDNEY HEALTH ALLIANCE OF KENTUCKY**, with offices located **1517 NICHOLASVILLE ROAD, SUITE 203, LEXINGTON KY 40503**, (hereinafter "Organization").

WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

1. Government hereby retains Organization for the period beginning on **July 1, 2021**, and continuing for a period of one (1) year from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.

2. Government shall pay Organization the sum of **\$10,000** for the services required by this Agreement, said services being more particularly described in the Addendum attached hereto and incorporated herein by reference as Exhibit A, one-half (1/2th) of which shall be payable in September 2021 or shortly thereafter upon receipt of an invoice, with one-half (1/2th) payable in January 2022 or shortly thereafter upon receipt of an invoice and the first six month detailed program report., **The first invoice required by this section shall be submitted by September 17th, 2021. The second invoice and the first six month detailed program report shall be due January 21st 2022. A detailed program report shall be submitted by April 15th, 2022. A year-end program report shall be submitted by July**

22nd, 2022. Failure to submit the April 2022 program report and the July 2022 year-end program report shall result in the Organization repaying one-half (1/2th) of total funds provided under this Agreement. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

3. In the event of termination of this Agreement by Government as provided for in paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.

4. Organization shall perform all duties and services included in the Addendum attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in the Addendum and for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and

5. Organization shall indemnify, defend and hold harmless Government, its officers, agents and employees, from and against any and all liabilities, claims, demands, losses, damages, costs, and/or expenses arising out of, from, relating to, and/or based on the Organization's violation of any such laws, ordinances or regulations or Organization's breach of this Agreement.

6. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.

7. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in the addendum attached hereto.

8. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.

9. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

10. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

11. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.

12. This instrument, and the Addendum incorporated herein, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.

13. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:

- A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
- B. Investment Funds Management: The governing board may elect to either:

(1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or

(2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

C. Investment Policies - - Safety and Prudence.

(1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

(2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.

(3) All investments shall be reviewed monthly by a finance or investment committee of the agency.

(4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.

D. Audit - - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #12-2021 Food Insecurity & Nutritional Access – Extended Social Resources (ESR) Grant Program** to be provided in accordance with terms, conditions and specifications established herein.

Proposals will be received **online only** at <https://lexingtonky.ionwave.net> until **2:00 PM**, prevailing local time, on **May 14, 2021**.

Proposals received after the date and time set for opening proposals will not be considered for award of a contract/grant. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted online before the date and time set for opening proposals.

Additional copies of this Request For Proposals are available from the Division of Central Purchasing, Room 338 Government Center, 200 East Main Street, Lexington, KY 40507, (859)-258-3320, at no charge.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Electronic signature online at <https://lexingtonky.ionwave.net> constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Pre-Proposal Meeting will be held on **April 30th, 2021 at 10:00AM EST** via Zoom (see section 3.1 in Scope of Work document for meeting link).

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and to promote equal employment through a positive, continuing program from itself and each of its subcontracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;

(3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and

(4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

(1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.

(2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the

contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available workforce in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

AFFIDAVIT

Comes the Affiant, Sarah Crouch, and after being first duly sworn, states under penalty of perjury as follows:

1. His/her name is Sarah Crouch and he/she is the individual submitting the proposal or is the authorized representative of Kidney Health Alliance of Kentucky, the entity submitting the proposal (hereinafter referred to as "Proposer").
2. Proposer will pay all taxes and fees, which are owed to the Lexington-Fayette Urban County Government at the time the proposal is submitted, prior to award of the contract and will maintain a "current" status in regard to those taxes and fees during the life of the contract.
3. Proposer will obtain a Lexington-Fayette Urban County Government business license, if applicable, prior to award of the contract.
4. Proposer has authorized the Division of Central Purchasing to verify the above-mentioned information with the Division of Revenue and to disclose to the Urban County Council that taxes and/or fees are delinquent or that a business license has not been obtained.
5. Proposer has not knowingly violated any provision of the campaign finance laws of the Commonwealth of Kentucky within the past five (5) years and the award of a contract to the Proposer will not violate any provision of the campaign finance laws of the Commonwealth.
6. Proposer has not knowingly violated any provision of Chapter 25 of the Lexington-Fayette Urban County Government Code of Ordinances, known as "Ethics Act."

7. Proposer acknowledges that "knowingly" for purposes of this Affidavit means, with respect to conduct or to circumstances described by a statute or ordinance defining an offense, that a person is aware or should have been aware that his conduct is of that nature or that the circumstance exists.

EQUAL OPPORTUNITY AGREEMENT

The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

The Contractor will not discriminate against any employee or applicant for employment because of physical or mental disability.

- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment Opportunity, states:

The Secretary of Labor may investigate the employment practices of any Government contractor or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have been violated.

The Lexington-Fayette Urban County Government practices Equal Opportunity in recruiting, hiring and promoting. It is the Government's intent to affirmatively provide employment opportunities for those individuals who have previously not been allowed to enter into the mainstream of society. Because of its importance to the local Government, this policy carries the full endorsement of the Mayor, Commissioners, Directors and all supervisory personnel. In following this commitment to Equal Employment Opportunity and because the Government is the benefactor of the Federal funds, it is both against the Urban County Government policy and illegal for the Government to let contracts to companies which knowingly or unknowingly practice discrimination in their employment practices. Violation of the above mentioned ordinances may cause a contract to be canceled and the contractors may be declared ineligible for future consideration.

GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, 29 U.S.C. 650 *et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.
4. Proposal Reservations: LFUCG reserves the right to reject any or all proposals, to award in whole or part, and to waive minor immaterial defects in proposals. LFUCG may consider any alternative proposal that meets its basic needs.
5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.
6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted

to bribe an officer or employee of the LFUCG.

9. Additional Information: While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. Agreement to RFP Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract/Grant under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
12. Cancellation: If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.

- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
- (a) Failure to perform the contract according to its terms, conditions and specifications;
 - (b) Failure to make delivery within the time specified or according to a delivery schedule fixed by the contract;
 - (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
 - (d) Failure to diligently advance the work under a contract for construction services;
 - (e) The filing of a bankruptcy petition by or against the contractor; or
 - (f) Actions that endanger the health, safety or welfare of the LFUCG or its citizens.

B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and

18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

5.1 Program Proposal & Design

5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

15 Points

Over 400 individuals receive dialysis treatment in Fayette County. 64% of these patients are over 65. 50% have household incomes below 125% of the Federal Poverty Guidelines. 47% of dialysis patients suffer from mild to moderate malnutrition due to inability to efficiently absorb protein (referred to as "protein energy wasting" -PEW), loss of appetite and a very restricted diet. This is worse in elderly patients where the malnutrition incidence rate jumps to 58%. A large part of the dialysis population in Fayette County is malnourished and needs renal specific protein supplementation to reduce PEW and maintain a healthy quality of life. Many have fixed or limited incomes due to the inability to work while on dialysis. Several of the appropriate renal protein supplement options are only available through online purchase and many dialysis patients do not have a checking account or credit card and some have no access to the internet. Additionally, not all protein supplements are appropriate for dialysis patients - sugar, sodium, potassium and phosphorus levels must all be considered. Finally, the appropriate supplements are expensive and outside the family budget. Food pantries generally do not offer the type of protein supplements these patients require. NSP was developed to provide the protein needed under the supervision of the renal dietitian and nephrologist, offering only those products approved for renal patients (usually 40% less than retail) through a system that delivers product to the patient at their dialysis clinic with the goal of eliminating malnutrition in the dialysis community.

5.1.2 Service Delivery Model

KHAKY administers the program through the registered dietitians serving the dialysis clinics. The program is available to all dialysis patients but the dietitians typically focus on those most malnourished and compromised by PEW. The dietitians help the patient select a product they like - and will use. The dietitian then gathers orders and payment from the patient to provide to KHAKY. We do have a new online order system for select clinics that allows the patient to go the website and order the products they need/want. Products are typically sold in cases or bottles that average 24 servings. KHAKY then orders the requested products from vendors through whom discounted pricing has been arranged. The clinic dietitians come to KHAKY to pick up their patient's orders and take them back to the clinic for distribution to the patients. The patient's nutrition is monitored closely as part of the patient's treatment plan at the clinic. Patient surveys and dietitian responses have confirmed that KHAKY's program provides an easily accessible, cost saving option for patients and is significant in helping improve and stabilize their nutritional health.

5.1.3 Client Eligibility and Requirements

All dialysis patients, patients with end-stage renal disease, are eligible for the program through their clinic dietitian. Patients are asked to pay the discounted price for the products they order at time of order. Those patients who qualify financially (household income below 125% of the federal poverty guideline) are able to order from a selection of free products or can receive up to \$10/month off any other products KHAKY offers.

5.1.4 Evidence-Based/Best Practice

Several research studies have been published concerning the loss of protein and resulting malnutrition in dialysis patients. In September, 2018, a paper was published based on a study by four specialists in the Department of Clinical Nutrition, Peking Medical College Hospital, Peking, China. The article, titled "The Effects of Oral Nutritional Supplements in Patients with Maintenance Dialysis Therapy (MDT): A Systematic Review and Meta-Analysis of Randomized Clinical Trials," is summarized below:

Patients undergoing dialysis often suffer from anorexia and a distortion in the sense of taste, which lead to inadequate protein intake, resulting in poor nutritional status and adverse outcomes. Several studies have reported that dietary protein intake were often lower than the recommendations for patients receiving dialysis. Moreover, the consensus from International Society of Renal Nutrition and Metabolism stated that in patients where oral dietary intake from regular meals could not maintain adequate nutritional status, nutritional supplementation is shown to be effective in replenishing protein and energy stores. Improving the nutritional status of patients with CKD by nutritional support is expected to decrease morbidity and mortality. Oral nutritional supplement is a simple and effective way to supplement energy and protein to malnourished patients. Therefore, if the protein of the regular diet is not enough, they should be supplemented with oral nutritional supplement when appropriate.

This latest article reinforces clinical evidence that initiated the development of the NSP at KHAKY. Overcoming obstacles to access to these supplements is a vital part of our role in the dialysis community.

5.2 Program Measures & Evaluation

5.2.1 Service Efficacy & Desired Outcomes

KHAKY's goal is to help renal dietitians help their dialysis patients maintain a healthy nutrition level and a better quality of life as a result. While KHAKY does not directly interact with patients, dietitians are required by Medicare and individual clinic quality outcome goals, to bring their patients to set targets for nutrition. KHAKY does not have access to individual medical records and our outcome success is measured only through the input of our participating dietitians and surveys from participating patients. The dietitians are met with annually at the Kentucky Renal Dietitians spring meeting. The attendees are polled regarding the success of the program and open discussion is encouraged regarding ways to improve. Additionally, KHAKY has a Patient Services Committee that oversees all patient service programs and activities. The committee consists of two KHAKY board members (one of whom is a kidney disease patient and the other a renal dietitian) and a renal social worker. The executive director also attends these meetings. The Patient Services Committee evaluates the program every other month and reviews suggestions from area dietitians for new products to add to the formulary KHAKY offers. All products are evaluated at least once a year for price/value considerations as well as popularity with the patients (based on sales).

5.2.2 Client Empowerment & Community Impact

10 Points

Chronic kidney disease and kidney failure is not a disease your "recover" from. While transplantation of a working kidney is close to a "cure," even that requires immune suppression for the rest of your life. Dialysis is a lifesaving treatment but not a replacement of your kidney function. The side effects of dialysis include muscle cramps and spasms, erratic fluctuations in blood pressure, changes to tastes, stress on the heart and other organs and as mentioned above, poor protein absorption leading to malnutrition. These complications are compounded by co-morbidities. More than 70% of dialysis patients have high blood pressure and/or diabetes. The added mental, financial and emotional stress of a chronic disease combine to form a serious health scenario. Multiple studies continue to show that patients who maintain a healthy nutrition are better equipped to handle the other complications of their disease. They exhibit better overall health, fewer hospitalizations and better mental/emotional health.

We have been told by patients (through surveys) and by dietitians about patients who, once nutritionally stabilized, were able to return to part-time work. Others have been able to go back to church regularly because they have more energy. Some are able to volunteer at local charities or just enjoy their family more. One elderly patient encouraged her friends to take supplements because they make you feel so much better and have so much more energy! Those may not seem like big things in an average person's life, but they are huge for patients living on dialysis.

5.2.3 Data Assessment & Quality Improvement

KHAKY monitors several aspects of the NSP. First, KHAKY continually looks for products and pricing that is more favorable for our patient base. This is done through annual pricing reviews of products currently offered and investigation of new products and providers for better products at better prices. Secondly, patient surveys are sent out twice a year with the July and January orders (on average 100-120 individual patients each time) asking them to share their opinion of their program, the effect it has on their health, and the importance of KHAKY's program in their overall healthcare plan. These surveys are collected by the clinic dietitians and returned to KHAKY where they are evaluated by the Patient Services Committee and KHAKY staff to monitor program effectiveness. Additionally, as mentioned earlier, annual meetings with the Kentucky Renal Dietitians helps keep KHAKY's program on the cutting edge of nutrition recommendations for dialysis patients and for effectiveness of the program KHAKY offers.

5.3 Capacity & Sustainability

5.3.1 Staff Qualifications & Experience

KHAKY is an organization that keeps its operating costs at a minimum in order to maximize its capacity to provide the programs and services of its mission. That means there is a high dependence on volunteer capacity.

Each semester KHAKY hosts two Eastern Kentucky University Public Health Administration interns (senior year) during summer and some fall and spring semesters. This provides support staff for receiving product, sorting and invoicing, facilitating order pickup and payments. Inventory counts and management are also part of their experience at KHAKY. The most important element in the NSP is the voluntary participation of the clinic dietitians. These dietitians are not required by their job to make supplements more readily available for their patients and facilitate the acquisition of those products. The dietitians do that in response to the need and the positive outcomes from these supplements. Their expertise and commitment to the program is critical for the program's ongoing success.

Record keeping and inventory control is maintained by the Executive Director of KHAKY. The ordering process has worked smoothly with dietitians emailing KHAKY what the patient wants for the month. As of May 2021 we have a new website that has the ability for patients to order online through our secure website. This website is in a trial run with select clinics.

The expertise of the individuals on the Patient Services Committee also adds to the safety, security, efficiency and comprehensiveness of the program.

5.3.2 Partnership & Resource Leverage

KHAKY's NSP fills a gap in the priority area that is specific to the needs of those on dialysis. Our relationships with the nine Fayette County dialysis centers is paramount in our ability to meet these needs.

KHAKY is an alliance of like-minded organizations and is supported financially with donations from two of the major dialysis providers in the country, Dialysis Clinics, Inc. and Fresenius Kidney Care. The UK Healthcare Transplant Center is also a major donor to the programs and services that KHAKY provides. These organizations also have representatives on the Board of Directors, Patient Services or other committees. These partnerships strengthen the participation of clinic employees in KHAKY programs and services. The support received is used to underwrite our statewide program efforts. Any additional funds needed are supplemented through fundraising events and efforts.

5.3.3 Outreach & Inclusion Strategy

The Kentucky Renal Dietitians are an affiliate group of KHAKY and the membership includes all clinic dietitians. In clinic registered dietitians are required by Medicare and nutritional stability is a goal of the individualized healthcare plans for their patients. While KHAKY does not interact directly with the patients, we are confident in the professionalism and patient care attention provided by the dietitians. 10% of the patients we serve in Fayette County are Hispanic, 37% are African American and 44% are below 125% of the Federal Poverty Guidelines. (We use 125% as our measure since cost of living for individuals and families dealing with chronic kidney disease is much higher than normal living expenses.)

KHAKY's program is available to all dialysis patients and is designed to require only enough demographic information to measure our community impact and only enough financial information to evaluate if additional financial support for product purchases is warranted.
