

TEMPORARY CONSTRUCTION EASEMENT

This **TEMPORARY CONSTRUCTION EASEMENT** is made and entered into this the 19 day of JANUARY, 2017, by and between **AMEILA KNAPP HILL and DAVID L. HILL, wife and husband**, 2065 Clays Mill Road, Lexington, Kentucky 40503, which is the in-care of tax mailing address for the current year ("Grantors"), and **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

WITNESSETH:

That for and in consideration of the sum of **SEVEN HUNDRED DOLLARS AND 00/100 (\$700.00)**, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantors have **BARGAINED** and **SOLD** and do hereby **GIVE, GRANT** and **CONVEY** unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform related work for the purpose of roadway improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, and more particularly described as follows, to wit:

(Harrodsburg Road to New Circle Road)

Being a tract of land lying in Fayette County on the west side of Clays Mill Road, point of beginning being approximately

29 feet north of the intersection of Springridge Drive and Clays Mill Road, and more particularly described as follows:

Beginning at a point 40.34 feet left of Clays Mill Road at Station 179+98.52; thence North 59 Degrees 41 Minutes 17 Seconds West a distance of 15.80 feet to a point 56.07 feet left of Clays Mill Road at Station 180+00.09; thence North 85 Degrees 48 Minutes 21 Seconds East a distance of 8.70 feet to a point 48.44 feet left of Clays Mill Road at Station 180+04.30; thence North 24 Degrees 08 Minutes 08 Seconds East a distance of 65.99 feet to a point 48.82 feet left of Clays Mill Road at Station 180+70.55; thence South 59 Degrees 30 Minutes 31 Seconds East a distance of 8.10 feet to a point 40.76 feet left of Clays Mill Road at Station 180+69.68; thence South 24 Degrees 08 Minutes 08 Seconds West a distance of 70.92 feet to a point 40.34 feet left of Clays Mill Road at Station 179+98.52 and the POINT OF BEGINNING.

The above described parcel contains 0.014 acres (590 sq. ft.) of temporary construction easement; and

Being a portion of the property conveyed to Amelia Knapp Hill, married, by deed dated March 1, 2016 of record in Deed Book 3380, Page 382, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, all of their right, title, and interest in and to the property to the extent of

the interest conveyed herein, including all exemptions allowed by law, and do hereby covenant to and with the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the same as herein done, and that they will **WARRANT GENERALLY** said title.

The obtaining of this easement was authorized by Resolution 477-2016, passed by the Lexington-Fayette Urban County Council on July 5, 2016. Pursuant to KRS 382.135(2)(c), this temporary construction easement, which pertains to a public right-of-way, need not contain a statement of consideration.
