

RESOLUTION NO. 148 - 2024

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AN AGREEMENT RELATED TO NEIGHBORHOOD DEVELOPMENT FUNDS WITH TATES CREEK HIGH SCHOOL PTSA, INC. (\$1,765.36); EDITH J. HAYES PTSA (\$200.00); GROWING TOGETHER PRESCHOOL, INC. (\$800.00); PENSACOLA PARK NEIGHBORHOOD ASSOCIATION, LLC (\$3,000.00); COMMUNITY ACTION COUNCIL FOR LEXINGTON-FAYETTE, BOURBON, HARRISON, AND NICHOLAS COUNTIES, INC. (\$800.00); SOUTHERN MIDDLE SCHOOL PTSA, INC. (\$2,000.00); PINNACLE HOMEOWNERS ASSOCIATION, INC. (\$3,846.00); LEXINGTON CHILDREN'S MUSEUM, INC. (\$2,300.00); AFRICAN AMERICAN ARTS ASSOCIATION, INC. (\$1,200.00); LEXARTS, INC. (\$2,375.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUM STATED.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute agreements related to Neighborhood Development Funds, which are attached hereto and incorporated herein by reference, with Tates Creek High School PTSA, Inc., Edith J. Hayes PTSA, Growing Together Preschool, Inc., Pensacola Park Neighborhood Association, LLC., Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc., Southern Middle School PTSA, Inc., Pinnacle Homeowners Association, Inc., Lexington Children's Museum, Inc., African American Arts Association, Inc., and LexArts, Inc. for the Office of the Urban County Council.

Section 2 – That amounts, not to exceed the sums stated, be and hereby are approved for payment to Tates Creek High School PTSA, Inc. (\$1,765.36); Edith J. Hayes PTSA (\$200.00); Growing Together Preschool, Inc. (\$800.00); Pensacola Park Neighborhood Association, LLC (\$3,000.00); Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc. (\$800.00); Southern Middle School PTSA, Inc. (\$2,000.00); Pinnacle Homeowners Association, Inc. (\$3,846.00); Lexington Children's Museum, Inc. (\$2,300.00); African American Arts Association, Inc. (\$1,200.00); LexArts, Inc. (\$2,375.00), from account #1101-121002-71214, from various Council Districts, pursuant to the terms of the agreements.
