

JustFundKY Cliff Todd Endowment Grant Agreement

JustFundKY has approved a Cliff Todd Endowment Grant of \$5000 payable to Lexington-Fayette Urban County Government designated for restricted use by LFUCG, the Grantee. This Grant is in support of the Grantee's activities as described in their 2020 Proposal, namely for painting of LGBTQ Themed Rainbow Crosswalks in downtown Lexington.

This Grant is subject to the following terms and conditions:

1. **Uses of the Grant:** Grantee shall use the Grant solely to carry out the activities described in Grantee's submitted proposal as specified above. No portion of the Grant funds will be used in support or opposition of any political candidate.
2. **Grant Period:** The Grant period begins July 1st, 2020 and ends June 30th, 2021. However, Grantee may commence grant implementation prior to July 1st.
3. **Payment of Grant:** The Grant will be scheduled for payment in one installment after signing, JustFundKY's receipt of the signed agreement, AND confirmation of the commencement date of the project. Grant funds will remain invested and then disbursed when needed by the Grantee. Grant check will be payable to the entity named on the IRS 501c(3) approval document submitted with the proposal unless otherwise requested and agreed.
4. **Required Reports:** Grantee will supply JustFundKY with both a financial and a narrative report detailing the expenditures and programmatic activities associated with the Grant upon completion of the Grant. End of year Grant Report is found on JustFundKY's website. Grantee will also participate in a mid-year progress update phone call to be scheduled by the Grantor.
5. **Grantee's Tax Status:** Grantee has been determined to be an organization that is tax-exempt pursuant to Internal Revenue Code Section 501c(3) or has a fiscal agent that is so exempt. Such determination remains in full force and has not been modified or rescinded. Grantee will notify Grantor of any change in its status.
6. **Identification of Grant Source:** Any program or project funded with a JustFundKY Grant must be identified to the public as JustFundKY sponsored or supported event. Information flyers about JustFundKY shall be provided to the Grantee and Grantee shall make them available to participants and the public at such events.

7. **Obligation to Share Information:** Grantor shall create social media (Facebook, Twitter, Instagram, etc.) posts and/or email advisories of the Grant and the Grantee shall share the posts and/or email to the Grantees' email list of members/contacts and social media followers. Grantee shall also repost the other 2020 JustFundKY Grant posts provided by the Grantor so that all 2020 Grantees will receive information on each others' work and effect broad dissemination and mutual benefit.

8. **Termination of Grant:** If Grantee fails to follow any of the terms and conditions of this Grant, Grantor will terminate this agreement, and further Grantee shall refund any unexpended funds to Grantor and will not be entitled to any further Grant funds. Neither grantee nor any fiscal sponsor may retain unexpended funds.
